- 5. The rates quoted shall be For JMRC office, Mansarovar Metro Depot, Jaipur-302020, Rate per unit will be inclusive of all taxes, packing charges and any other charges, no other charges shall be paid by JMRC.
- 6. GST will be paid at rate applicable at the time of billing.
- 7. Delivery Period: The material is to be supplied within 45 days of issue of purchase order if extension in delivery period is not approved by competent authority.

8. Liquidated Damages:

If material not supplied within delivery period as mentioned in RFQ, then contractor shall be held responsible for liquidated damages. The total damages shall not exceed 10(Ten) percent of the value of delayed goods. However decision of procuring entity shall be final in this regard. The offer shall be unconditional and duly signed.
