- 6. Bids sent telegraphically or through other means of transmission (Email, Telefax etc.), which cannot be delivered in a sealed envelope, shall be treated as defective, invalid and shall stand rejected.
- 7. The uploaded documents for e-bidding cannot be changed after closing date of bid and same documents are to be produced in original physical form in the office whenever asked to do so.

2.5 EVALUATION OF BID



 The bid will be opened online on website at the time and date as per schedule specified in the Notice Inviting Bid in the presence of Bidder's or their authorized representative's who may choose to be present at the time of bid opening, if the



bidder wishes. Participating bidders can view and access the outcome of technical bid online also.

2. The bids shall be opened in two part/cover. In first part/cover, the technical bid shall be opened and evaluated. In second part/cover, Financial Bid of all technically qualified bidders, who qualify the technical evaluation will be opened on the date and time intimated to all such bidders separately by email. Bidders are also advised to keep abreast of the website for announcement of the date.

Preliminary Examination of Bids

- a. The contents of the documents of the individual bids will be examined summarily in order to assess their formal conformity and agreement with the instructions and guidance to the Bidders and the completeness as per eligibility criteria and technical responsiveness. Any bid not conforming to any of these requirements may be disqualified forthwith at the discretion of Jaipur Metro Rail Corporation.
- b. The ranking of L1, L2, L3 etc, will be done on basis of least Cost for overall items of financial BOQ.

2.6 NEGOTIATION

- 1. Except in case of procurement by method of single source procurement or procurement by competitive negotiations, to the extent possible, no negotiations shall be conducted after the pre-bid stage. All clarifications needed to be sought shall be sought in the pre-bid stage itself
- 2. Negotiations may, however, be undertaken only with the lowest or most advantageous bidder under the following circumstances-
 - a) When ring prices have been quoted by the bidders for the subject matter of procurement; or
 - b) When the rates quoted vary considerably and considered much higher than the prevailing market rates.
- 3. The bid evaluation committee shall have full powers to undertake negotiations. Detailed reasons and results of negotiations shall be recorded in the proceedings.
 - The lowest or most advantageous bidder shall be informed in writing either through messenger or by registered letter and email (if available). A minimum time of seven days shall be given for calling negotiations. In case of urgency the bid evaluation committee, after recording reasons, may reduce the time, provided the lowest or most advantageous bidder has received the intimation and consented to regarding holding of negotiations.
- 4. Negotiations shall not make the original offer made by the bidder inoperative. The bid evaluation committee shall have option to consider the original offer in case the bidder decides to increase rates originally quoted or imposes any new terms or conditions.

In case of non-satisfactory achievement of rates from lowest or most advantageous bidder, the bid evaluation committee may choose to make a written counter offer to the lowest or most advantageous bidder and if this is not accepted by him, the committee may decide to reject and re-invite bids or to make the same counter-offer first to the second lowest or most advantageous bidder, then to the third lowest or most advantageous bidder and soon in the order of their initial standing and work / supply order be awarded to the bidder





who accepts the counter-offer. This procedure should be used in exceptional cases only.

In case the rates even after the negotiations are considered very high, fresh bids shall be invited.

2.7 AWARD OF CONTRACT & PERFORMANCE SECURITY DEPOSIT

- 1. The Employer will award LOA to the bidder, whose bid has been determined to be substantially responsive, technically & financially suitable, complete and in accordance with the bid documents.
- 2. The successful Bidder shall submit a Performance Security Deposit equal to 5% of LOA/PO, in the form of Demand draft/FDR or Bank Guarantee from any scheduled bank in favour of Jaipur Metro Rail Corporation Ltd within 30 days from the date of issue of LOA. In case of deposition of performance security in form of bank guarantee, then the Bank Guarantee will be executed on stamp paper (of any state) of 0.25% of Bank guarantee amount.
- 3. The Bank Guarantee has to be from a Scheduled Bank based in India and the Form of Performance Security provided in this Volume shall be used.
- 4. The Performance Bank Guarantee (Security Deposit) should remain valid for a minimum period of 3 years (2 Years of contract period and 1 year for warranty period) and 60 days beyond the date of completion of validity and all contractual obligations of Agency.
- 5. If the Bidder fails to deposit the required Performance Security Deposit, such failure will be treated as a breach of the terms and conditions of the bid and will result in forfeiture of the Earnest Money/Bid Security, in part, or in full at the discretion of the Procuring Entity. This failure shall also result in cancellation of bid.
- 6. Performance Security will be returned after 60 days of completion of all contractual obligations of the Bidder.
- 7. No interest shall be payable on the Performance Security Deposit.

2.8 Additional Performance Security:-

a. In addition to Performance Security as specified in rule 75, an Additional Performance Security shall also be taken from the successful bidder in case of unbalanced bid. The Additional Performance Security shall be equal to fifty percent of Unbalanced Bid Amount. The Additional Performance Security shall be deposited in lump sum by the successful bidder before execution of Agreement. The Additional Performance Security shall be deposited through e-Grass, Demand Draft, Banker's Cheque, Government Securities or Bank Guarantee.

Explanation: For the purpose of this rule,-

- i. Unbalanced Bid means any bid below more than fifteen percent of Estimated Bid Value.
- **ii.** Estimated Bid Value means value of subject matter of procurement mention in bidding documents by the Procuring Entity.
- **iii.** Unbalanced Bid Amount means positive difference of eighty five percent of Estimated Bid Value minus Bid Amount Quoted by the bidder.
- b. The Additional Performance Security shall be refunded to the contractor after satisfactory completion of the entire work. The Additional Performance Security shall be forfeited by the Procuring Entity when work is not completed within stipulated period by the contractor. Provision for 'Unbalanced Bid' and 'Additional Performance Security' shall be mentioned in the Bidding Documents by the Procuring Entity."



2.9 SIGNING OF AGREEMENT

1. The Employer shall prepare the Agreement on non-judicial stamp as per stamp act, in the Performa, included in this Document, duly incorporating all the terms of agreement between the two parties. Within 30 days from the date of issue of the letter of acceptance, the successful bidder will be required to execute the Contract Agreement. One copy of the Agreement duly signed by the Employer and the contractor through their authorized signatories will be supplied by the Employer to the Contractor.

Brake

- 2. Prior to signing of the Contract Agreement, the successful bidder shall submit the following documents within a period of 30 days from the date of issue of the Letter of Acceptance:
 - **a.** Performance Security (Performance Guarantee)
 - **b.** Detailed Consortium or Joint Venture Agreement (duly signed and executed)

Incorporating (if applicable):

- i. Percentage Participation of each member/partner.
- ii. Joint and several liability of the partners

3 GENERAL CONDITIONS OF CONTRACT

3.1GENERAL Terms & Conditions

3.1.1 Contract Documents:

Subject to the order of precedence set forth in the Agreement, all documents forming the Contract (and all parts thereof) are intended to be correlative, complementary, and mutually explanatory.

3.1.2 J V Conditions:

- If the <u>Bidder</u>is a JV/Consortium having foreign partner(s) and above work(s) have been executed by the foreign partner of JV and the work(s) were done in the country of the foreign partner, then in addition to this the foreign partner must have executed works (which need not be similar in nature) of total put together of value INR 65,45,534/-or more outside the country of the foreign partner.
- 2. The Bidder shall submit details of works executed by them in the Performa prescribed in Form-L & Form-M of FOB for the works to be considered for qualification of work experience criteria. Documentary proof such as completion certificates from client clearly indicating the nature/scope of work, actual completion costand actual date of completionfor such work should be submitted. The offers submitted without this documentary proof shall not be evaluated. In case the work is executed for private client, copy of work order, bill of quantities, bill wise details of payment received certified by C.A., T.D.S certificates for all payments received and copy of final/last bill paid by client shall besubmitted.



In the case of Bidder being a joint venture of two or more firms or companies as partners or as members of consortium as the case may be, joint venture data must be submitted along with the documents as mentioned therein. The following requirements shall also be complied with.

a. The Bid, and, in the case of a successful Bid, the Form of agreement, shall be individually signed so as to be legally binding on all partners/constituents as the case may be.

Brake

- b. In case of partnership, one of the partners shall be nominated as being in charge as lead or prime partner and this authorization shall be evident by submitting a power of attorney signed by the partner or legally authorized signatories of all the partners. In case of consortium, It will similarly authorize a person to be in-charge and this authorization shall be evident by a power of attorney in favour of that person.
- c. The partner in-charge or the person in-charge as aforesaid shall be authorized to incur liabilities and receive instructions for and on behalf of any and all the partners of the joint venture or constituents of the consortium and the entire execution of the contract including payment shall be carried out exclusively through the partner in-charge of joint venture and person in-charge of a consortium.
- d. All partners of the joint venture or constituents of the consortium shall be liable jointly and severally for the execution of the contract in accordance with the contract terms and a relevant statement to this effect shall be included in the authorization mentioned under (b) above as well as in the form of Bid and the form of agreement (in case of a successful Bid).
- e. In the event of default by any partner in the case of a joint venture and constituent in the case of a consortium in the execution of his part of the contract, the partner/person in-charge will have the authority to assign the work to any other party acceptable to the employer to ensure the execution of that part of the contract.
- f. A copy of the agreement entered into by the joint venture/consortium partners shall be submitted along with the Bid.

In case the Bidder is an Association, consortium or joint venture, the Bidder shall provide the following:

- a) The memorandum of understanding / joint venture agreement duly notarized indicating.
- b) Nomination of one of the members of the association, consortium or joint venture to be in-charge or lead member. This authorization shall be issued by the legally authorized signatories of all members of the association, consortium or joint venture.
- c) Details of the intended percentage participation given by each member, with complete details of the proposed division of responsibilities and corporate relationships among the individual members.
- d) Each member of the association, consortium or joint venture shall be jointly and severally liable for the under taking of this contract.
- e) JV/Consortium:
 - i.) There can be a maximum of 3 (three) members in a JV/Consortium.
 - ii.) The technical and financial capabilities of only those members with equity stake equal to or greater than 26% in the JV/Consortium shall be considered relevant for evaluation. It is clarified that the technical



experience and financial capabilities of any other Group Company or holding company or subsidiary company of any bidder / JV/Consortium member shall not be considered for evaluation unless such company is also a part of the JV/Consortium with minimum 26% stake in the shareholding of the JV/Consortium.

iii.) The JV/Consortium as a whole (with cumulative effect) may satisfy the eligibility criteria i.e. the Technical Bid.

Brake

- iv.) Each JV/Consortium must specify the proposed equity shareholding (FORM-I) and nominate a Lead Member of the consortium. This shall be enshrined in the Memorandum of Agreement signed by all JV/Consortium members and submitted along with the Bid. The Consortium agreement should be on non-judicial stamp paper signed by each & every authorized signatory along with their copy of authorized Power of Attorney duly notarized.
- v.) If the successful bidder is a consortium of firms, the Contract Agreement shall be signed with entire consortium i.e. all the consortium members shall be party to the Contract Agreement.
- vi.) There will be no change in the consortium's proposed shareholding structure in the submitted Bid, till the completion of the contract in all respect.
- vii.) all parties to the Joint Venture shall sign the bid and they shall be jointly and severally liable;

and

- a Joint Venture shall nominate a representative who shall have the authority to conduct all business for and on behalf of any or all the parties of the Joint Venture during the bidding process. In the event the bid of Joint Venture is accepted, either they shall form a registered Joint Venture company/firm or otherwise all the parties to Joint Venture shall sign the Agreement.
- viii.)All members of the JV/Consortium shall be liable jointly and severally, for the execution of the project in accordance with the terms of the Contract Agreement. However, a single performance guarantee from the lead member only shall be submitted for the consortium.
- ix.) Any individual bidder or member of a JV/Consortium cannot be a member in another JV/Consortium and participate in this Bid.
- x.) Any member of JV/Consortium shall not have been blacklisted/debarred.

3.1.3 Scope of Supply

Subject to the provisions in the bidding document and contract, the execution of complete scope of work shall be executed as specified in the purchase order/LOA which will be issued by JMRC to the successful bidder.

3.1.4 Delivery

1. Subject to the conditions of the contract, the supply and services shall be executed within the two months time from the date of issue of LOA which will be issued by JMRC to the successful bidder. However decision of engineer in charge in this regards shall be final.





- 2. Contract Period is Two Years from the date of issue of LOA (Letter of Acceptance)
- 3. The Bidder shall lift normally all two types of Brake caliper units of one train set from nominated Engineer of JMRC in one lot. However, quantity of Brake caliper units per lot may be varying as per JMRC requirements.
- 4. Bidder may note that there may be a gap of 1 to 3 months for availability of next lot of Brake caliper units depending upon the availability of Trains in the Depot. As such no extra charges will be payable to Bidder for above gap period. However decision of engineer in charge in this regards shall be final.
- 5. However, Bidder will be informed sufficiently in advance (10 days) about availability of Brake caliper units. The Bidder shall lift each lot of Brake caliper units within five working days from the date of intimation and shall return the lifted each lot of Brake caliper units after completion of required work (overhauling & testing) including test certificate, replaced item (that was replaced either mandatory or conditional basis), checklist etc. within a max of four weeks (30 calendar days) from the day of lifting.
- 6. The firm will ensure the delivery of tested Brake caliper units within specified timelimit failingwhichactionwillbetakenunderthepenaltyclause.

3.1.5 Inspection

The Work executed shall be inspected by nominated JMRC staff. The documentary reports, work completion reports for the same is to be submitted to JMRC. JMRC representative, during and after overhauling & testing of brake calipers may carry out the inspection of material at contractor premises. This inspection of material is solely jurisdiction of JMRC. Final inspection of the repaired material will be done after fitting the repaired material in Rolling Stock (RS8)

3.1.6 Termination

- 1. Termination for Default
 - The Bid inviting authority of JMRC may, without prejudice to any other remedy for breach of contract, by a written notice of default of at least 30 days sent to the supplier/*Contractor, terminate the contract in whole or in part: -
 - a. If the supplier/ Contractor fails to deliver any or all quantities of the service within the time period specified in the contract, or any extension thereof granted by JMRC; or
 - If the supplier/ Contractor fails to perform any other obligation under the contract within the specified period of delivery of service or any extension granted thereof; or
 - c. If the supplier/ Contractor, in the judgment of the Purchaser, is found to be engaged in corrupt, fraudulent, collusive, or coercive practices in competing for or in executing the contract.
 - d. If the supplier/ Contractor commits breach of any condition of the contract.
- 2. If JMRC terminates the contract in whole or in part, amount of Performance Security Deposit may be forfeited.
- 3. Before cancelling a contract and taking further action, advice of senior most finance person available in the office and of legal adviser or legal assistant posted in the office, if there is one, may be obtained.





Note: In addition to the conditions specified above, the approved GCC are applicable and available on the JMRC website. The successful bidder shall submit a declaration for acceptance of the terms and conditions mentioned the GCC.

Brake

3.1.7 Transportation:

The rate quoted in BOQ shall include the cost of transport of item including all incidental arrangements for safe transport of items.

3.1.8 Warranty:

1. The Bidder shall ensure a Warranty of 12 months for overhauled Brake caliper units from the date of receipt of overhauled Brake caliper units at respective depot of JMRC. The Brake caliper units failed within the Warranty/Guarantee period shall be overhauled again by the Bidder free of cost including to & fro charges of the Road transport. And warranty period will be extended from the date of receipt of re-overhauled of failed Brake caliper units i.e. 12 months as above. However, the warranty will be applicable only for poor quality of materials or bad workmanship.

3.1.9 Price Fall Clause:

- 1. The prices under a rate contract shall be subject to price fall clause. A clause regarding price fall shall be incorporated in the terms and conditions of rate contract. Price fall clause is a price safety mechanism in rate contracts and it provides that if the rate contract holder quotes / reduces its price to render similar goods, works or services at a price lower than the rate contract price to anyone in the State at anytime during the currency of the rate contract, the rate contract price shall be automatically reduced with effect from the date of reducing or quoting lower price, for all delivery of the subject matter of procurement under that rate contract and the rate contract shall be amended accordingly.
- 2. The firms holding parallel rate contracts shall also be given opportunity to reduce their price by notifying them the reduced price giving those fifteen days time to intimate their acceptance to the revised price. Similarly, if a parallel rate contract holding firm reduces its price during currency of the rate contract, its reduced price shall be conveyed to other parallel rate contract holding firms and the original rate contract holding firm for corresponding reduction in their prices. If any rate contract holding firm does not agree to the reduced price, further transaction with it, shall not be conducted.

4 SPECIAL TERMS AND CONDITIONS OF BID & CONTRACT

4.1 Bidders to Bid for all Items

4.1.1 Bidder must quote for all the items mentioned in the BOQ (Bill of Quantities). In case, a Bidder does not quote for any item, the bid shall be summarily rejected.

4.2 Payment Terms and Penalty

1.2.1 If, the work is delayed beyond stipulated time period (30 calendar days) from the date of lifting of each lot of Brake caliper units, Liquidated Damages (L.D.)



- as per clause 4.2.2 below will be applicable. The engineer's decision in this regard will be final.
- 4.2.2 If material not supplied within contract period as mentioned in NIB, then contractor shall be held responsible for liquidated damages. The liquidated damages is compensation of loss on account of late delivery (actually incurred as well as notional) where loss is pre-estimated and mutually agreed to procuring entity may recover from the contractor, as agreed, the liquidated damages a sum equivalent to 0.5(one half) percent of the prices of any portion of stores delivered late, for each week or part thereof of delay. The total damages shall not exceed 10(Ten) percent of the value of delayed goods. However decision of procuring entity shall be final in this regard. The offer shall be unconditional and duly signed.
- 4.2.3 Advance Payment will not be made by JMRC.
- 4.2.4 Due payments will be made promptly, after submission of an invoice or request for payment by the supplier/ Contractor, and the purchaser has accepted it.
- 4.2.5 The currency or currencies in which payments shall be made to the supplier/ Contractor under this Contract shall be Indian Rupees (INR) only.
- 4.2.6 All remittance charges will be borne by the supplier/ Contractor.
- 4.2.7 Payment of the work executed shall be made only when the work completed as specified in this bid, and the work is found to be satisfactory and accepted by the inspecting authority.
- 4.2.8 If bidder fails to submit performance security, execution of contract within specified time, no payment shall be made for the work, if any done after issuance of LOA/PO

4.3 Other Special Terms

- 4.3.1 Bidders are advised to carry out extensive survey and site visit and analysis at their own cost, before submitting the bid as per JMRC extent procedures and permission.
- 4.3.2 Accidents It shall be the entire responsibility of the contractor to adopt all the safety measures in deploying personnel who are adequately trained in safety. If any accident occurs due to negligence on the part of the contractor's personnel, it shall be the full responsibility of the contractor.
- 4.3.3 Contractor shall be responsible for insurance and safety of the labor involved in executing the scope of work of this BID.
- 4.3.4 The contractor shall insure JMRC's material, against all losses or damages during transit or otherwise, in the joint names of the Employer (JMRC) & contractor.
- 4.3.5 This insurance shall be valid from the handover of the material to contractor & this should be valid till the material is received at JMRC's designated depot after carrying out the work as per the scope of the contract.
- 4.3.6 The contractor shall furnish the insurance before lifting the material for undertaking the contractual work in hand.
- 4.3.7 The contractor shall make sure that no harm or damage is made to JMRC property and assets while executing the scope of work of this BID. The performance security/payment shall be forfeited or shall be refunded/ made only after making the adjustments for any such damage made by the contractor and his staff.



4.4 Variation

- 4.4.1 Procuring entity has the right to vary the quantity/period as per RTPPR-2013
- 4.4.2 If the procuring entity does not procure any subject matter of procurement or procures less than the quantity specified in the bidding documents due to change in circumstances, the bidder shall not be entitled for any claim or compensation except otherwise provided in the bidding documents.
- 4.4.3 Repeat orders for extra items or additional quantities may be placed, on the rates and conditions given in the contract. Delivery or completion period may also be proportionately increased. The limits of repeat order shall be as under-
- (a) 50% of the quantity of the individual items and 50% of the value of original contract in case of works; and
- (b) 50% of the value of goods or services of the original contract.

5 SCOPE OF WORK:

5.1 Employer's Requirement

- 5.1.1 The Bidder shall execute the work i.e. overhauling& testing of Brake caliper units with Service brake& parking brake of RS-8 JMRC Trains and submit test report with fit/not fit mark.
- 5.1.2 The detailed break up of activities and sub-activities with proposed distribution of responsibilities between JMRC and Bidder will be as under:


5.2 Brief Scope of Work

- 5.2.1 The Bidder shall execute the work i.e. "overhauling & Testing of Brake caliper units of RS-8 JMRC Trains and submit test report with fit/not fit mark" including all man power, overhauling kit, machine, tools, transport etc.
- 5.2.2 This contract is for testing of Brake caliper units of 320 Nos. different Types of Brake caliper units (Brake caliper unit of Service brake & parking brake) of RS8 JMRC Trains. The quantity of Brake caliper units may vary as per requirements of JMRC.

5.2.3 Details ofBrake caliper units areasgivenbelow:

- 5.2.4 During work of "overhauling &testing of Brake caliper units of RS-8 JMRC Trains and submit test report with fit/not fit mark", the following steps to be carried out by the Bidder.
- 5.2.5 Brake caliper units after removal from cars (with the help of Bidder) shall be offered by JMRC Engineer to the representative of the Bidder in assembled condition along with delivery note with Id number of each Brake caliper units & type of Brake caliper units.
- 5.2.6 Bidder shall provide the Suitable lockable boxes/containers/stands with fixing arrangement for Brake caliper units (if required).
- 5.2.7 Packing of Brake caliper units in stands/boxes/containers and loading of Brake caliper units stand/boxes/containers into the truck at JMRC's depot shall be arranged by the Bidder.
- 5.2.8 After loading in truck, the Bidder shall give acknowledgement receipt of Brake caliper units to JMRC Engineer through his authorized representative.
- 5.2.9 The working time for the packing and transportation of Brake caliper units from the JMRC's depot will be between 09.00 am to 05.30 pm with half an hour lunchbreakinbetweenonallworkingdays.
- 5.2.10 The freight charges both ways of the road transport from JMRC depot to Bidder's workshop and back will be borne by the Bidder at their own cost and the same will be billed to the JMRC as per accepted bill of quantity.
- 5.2.11 Unloading of Brake caliper units from the truck at the Bidder's work will be arranged by the Bidder at their own cost.
- 5.2.12 The Overhauling & testing of Brake caliper units (All two types) of RS8 trains will be carried out by Bidder for 10 train sets (4cars) subject to follow the





procedure as mentioned in OEM(KBI)brake manual. Packing of all tested Brake caliper units will be in suitable wooden pallets/boxes/stands. Loading of tested Brake caliper units(accepted/rejected)in the truck at the Bidder work center will be arranged by the Bidder at their own cost.

5.2.13 Unloading of the boxes/containers of the overhauled/rejected Brake caliper units from the truck at JMRC Depot shall be arranged by Bidder at their own cost. After unloading from truck at JMRC depot, the nominated Engineer of JMRC shall give acknowledgement receipt of tested Brake caliper units (accepted/rejected) on the basis oftest reports, physical conditions and fulfillment of standard parameter on delivery of the same by the authorized representative of Bidder.

- (g) Disclose conflict of interest, if any; and
- (h) Disclose any previous transgressions with any Entity in India or any other country during the last three years or any debarment by any other procuring entity.

Conflict of Interest:-

The Bidder participating in a bidding process must not have a Conflict of Interest. A Conflict of Interest is considered to be a situation in which a party has interests that could improperly influence that party's performance of official duties or responsibilities, contractual obligations, or compliance with applicable laws and regulations.

- g. Bidder or any of its affiliates has been hired (or is proposed to be hired) by the Procuring Entity as engineer-in-charge/consultant for the contract.

(1) Filing an appeal

If any Bidder or prospective bidder is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issued there under, he may file an appeal to First Appellate Authority, as specified in the Bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Provided that after the declaration of a Bidder as successful the appeal may be filed only by a Bidder who has participated in procurement proceedings:

Provided further that in case a Procuring Entity evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter of Financial Bids may be filed only by a Bidder whose Technical Bid is found to be acceptable.

- (2) The officer to whom an appeal is filed under Para (I) shall deal with the appeal as expeditiously as possible and shall endeavor to dispose it within thirty days from the date of the appeal.
- (3) If the officer designated under para (1) fails to dispose of the appeal filed within the period specified in para (2), or if the Bidder or prospective bidder or the Procuring Entity is aggrieved by the order passed by the First Appellate Authority, the Bidder or prospective bidder or the Procuring Entity, as the case may be, may file a second appeal to Second Appellate Authority specified in the Bidding Document in this behalf within fifteen days from the expiry of the period specified in para (2) or of the date of receipt of the order passed by the First Appellate Authority, as the case may be.

(4) Appeal not to be in certain cases

No appeal shall lie against any decision of the Procuring Entity relating to the following matters, namely:-

- (a) determination of need of procurement;
- (b) provisions limiting participation of Bidders in the Bid process;
- (c) the decision of whether or not to enter into negotiations;
- (d) cancellation of a procurement process;
- (e) Applicability of the provisions of confidentiality.

(5) Form of Appeal

(a) An appeal under para (I) or (3) above shall be in the annexed Form along with



as many Copies as there are respondents in the appeal.

(b) Every appeal shall be accompanied by an order appealed against, if any, affidavit verifying the facts stated in the appeal and proof of payment of fee.

(c) Every appeal may be presented to First Appellate Authority or Second Appellate Authority, as the case may be, in person or through registered post or authorized representative.

(6) Fee for filing appeal

- (a) Fee for first appeal shall be rupees two thousand five hundred and for second appeal shall be rupees ten thousand, which shall be non-refundable.
- (b) The fee shall be paid in the form of bank demand draft or banker's cheque of a Scheduled Bank in India payable in the name of Appellate Authority concerned.

(7)Procedure for disposal of appeal

- (a) The First Appellate Authority or Second Appellate Authority, as the case may be, upon filing of appeal, shall issue notice accompanied by copy of appeal, affidavit and documents, if any, to the respondents and fix date of hearing.
- (b) On the date fixed for hearing, the First Appellate Authority or Second Appellate Authority, as the case may be, shall,-
 - (i) Hear all the parties to appeal present before him; and
 - (ii) Peruse or inspect documents, relevant records or copies thereof relating to the matter.
- (c) After hearing the parties, perusal or inspection of documents and relevant records or copies thereof relating to the matter, the Appellate Authority concerned shall pass an order in writing and provide the copy of order to the parties to appeal free of cost.
- (d) The order passed under sub-clause (c) above shall also be placed on the State Public Procurement Portal
