

- 2.8.2 The Bid, as well as all correspondence and documents relating to the Bid exchanged by the bidders and the procuring entity, shall be written only in English/ Hindi Language. - 4.3.11 The quantity of work may vary as per site requirement during contract period/extended period and this shall be governed as per RTPPR 2013.
