2.0 INSTRUCTION TO BIDDERS

2.1 Sell of Bidding/ Bid Documents

- 2.1.1.1 The sell of bid document shall be commenced from the date of publication of Notice Inviting Bid (NIB). The complete bid document shall also be placed on the State Public Procurement Portal and JMRC website as per NIB. The prospective Bidder shall download the bidding document from the specified website(s) and pay its bid cost on or before while submitting the bid to the procuring entity.
- 2.1.1.2 The bid document shall be made available to any prospective Bidder who pays the Bid cost for it in cash or by bank demand draft, banker's cheque Bid document cost is not refundable.

2.2 Cost of bid document and Bid Security/EMD

- 2.2.1 The BID should be submitted in the prescribed Bid document, which may be purchased for Rs. 118/- including 18% GST by DD/Banker Cheque drawn in favour of "Jaipur Metro Rail Corporation Ltd", payable at Jaipur. The complete bid document can also be downloaded from the website <http://transport.rajasthan.gov.in/jmrc> or www.sppp.rajasthan.gov.in.
- 2.2.2 EMD/Bid Security can be deposited in the form of Demand Draft/ Bankers Cheque of amount as mentioned in NIB Section 1 of this bid document drawn in favour of "Jaipur Metro Rail Corporation Ltd", payable at Jaipur, shall form part of the bid.
- 2.2.3 Bid security shall be 2% of the estimated value of subject matter of procurement bid.
- 2.2.4 The Bid Security of unsuccessful Bidder shall be refunded soon after final acceptance of successful bid and submitting performance security.
- 2.2.5 The Bid Security taken from a bidder shall be forfeited, including the interest, if any, in the following cases, namely: -
- when the bidder withdraws or modifies its bid after opening of bids;
 - when the Bidder fails to commence the supply of the goods or service or execute work as per supply/ work order within the time specified;
 - when the Bidder does not deposit the performance security within specified period after the supply/ work order is placed; and
 - If the Bidder breaches any provision of code of integrity, prescribed for Bidders, specified in the bidding document. Notice will be given to the Bidder with reasonable time before Bid Security (EMD) deposited is forfeited.
- 2.2.6 Notice will be given to the Bidder with reasonable time before Bid Security (EMD) deposited is forfeited.
- 2.2.7 No interest shall be payable on the Bid Security (EMD).
- 2.2.8 The procuring entity shall promptly return the Bid Security of the successful Bidder after the earliest of the following events, namely:-
- the expiry of validity of Bid Security;
 - Issue of LOA for procurement and performance security is furnished by the successful Bidder;

- c. the cancellation of the procurement process; or
- d. The withdrawal of bid prior to the deadline for presenting bids, unless the bidding documents stipulate that no such withdrawal is permitted.

2.3 Changes in the Bidding Document

- 2.3.1.1 At any time, prior to the deadline for submission of Bids, the procuring entity may for any reason, whether on its own initiative or as a result of a request for clarification by a Bidder, modify the bidding document by issuing an addendum in accordance with the provisions below.
- 2.3.1.2 In case, any modification is made to the bidding document or any clarification is issued which materially affects the terms contained in the bidding document, the procuring entity shall publish such modification or clarification in the same manner as the publication of the initial bidding document.
- 2.3.1.3 In case, a clarification or modification is issued to the bidding document, the procuring entity may, prior to the last date for submission of Bids, extend such time limit in order to allow the bidders sufficient time to take into account the clarification or modification, as the case may be, while submitting their Bids.

2.4 Period of Validity of Bid

- 2.4.1.1 Bids submitted by the Bidders shall remain valid during the period specified in the NIB/ Bid document. A Bid valid for a shorter period may be rejected by the procuring entity as non-responsive Bid.
- 2.4.1.2 Prior to the expiry of the period of validity of Bids, the procuring entity, in exceptional circumstances, may request the Bidders to extend the bid validity period for an additional specified period of time. A Bidder may refuse the request and such refusal shall be treated as withdrawal of Bid and in such circumstances Bid Security shall not be forfeited, if applicable.

2.5 Format and Signing of Bid

- 2.5.1.1 The Bidder shall prepare one original set of the bidding documents called Bid in the manner as specified in the bidding document.
- 2.5.1.2 All pages of the bid shall be signed by the Bidder or a person duly authorized to sign on behalf of the Bidder, in token of acceptance of all the terms and conditions of the bidding documents. This authorization shall consist of a written confirmation as per "Certificate of Conformity/ No-Deviation" of the bidding document and shall be attached to the technical bid.
- 2.5.1.3 Any corrections in the bid such as interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by the person signing the bid.

2.6 Sealing and Marking of Bid

- 2.6.1.1 The Bids shall be submitted as per Single Stage Single Envelope system as described below in person at the **O/o Manager (Operations), 417, Admin Building, Metro Depot, Bhrigu Path, Mansarovar, Jaipur-302020**. Completed Bid Package sent by the post/ courier for submission

shall be reach at venue before the schedule date & time and delay on part of post/courier or loss of the bid shall be sole responsibility of the bidders.

2.6.1.2 The Bids shall be submitted in One Envelope duly super scribed from the bidders the NIB No., Name of Work & Date and time of opening of Bid and "Bid Package" along with name, address and contact (mobile no.) Particulars of the Bidders.

2.6.1.3 The Bid Package Envelope shall contain the following:

2.6.1.3.1 An undertaking that there are No Technical or Financial deviations or additional Conditions incorporated in the Bid document.

2.6.1.3.2 The bidder shall enclose duly signed and stamped copy of the Bid Document, BOQ and all required submittals.

2.6.1.3.3 **Bid Cost and Bid Security:** Bid cost and Bid security shall be enclosed as Para 2.2 of ITB of Bid Document.

2.6.1.3.4 **Power of Attorney:** In accordance with relevant clause and authorization for executing the power of attorney as per clause 16(d) of NIB. (Form H) (If applicable).

2.6.1.3.5 **Corrigendum:** Any Corrigendum / Amendment issued up to last date / time of submission of NIT & Uploaded / Posted on website.

2.6.1.3.6 **Check list as per clause 8.0.**

2.6.1.4 The Bid should be properly bound and sealed. In case of loose/spiral bound submission of Bid, the Bid may be liable for rejection.

2.6.1.5 JMRC will not be responsible for Bid Documents delivered to any other place/person in JMRC other than the designated officer and does not reach the designated officer before the deadline for submission. JMRC will not be responsible for delay in submission due to any reason.

2.6.1.6 All pages of the bid document and the addendums/amendments uploaded by the JMRC on the website <https://sppp.rajasthan.gov.in> shall be deemed to have been initialed and accepted by the persons signing the bid when they submit their bid.

2.6.1.7 The documents listed in ITB clause along with the addendum's uploaded till the date of bid of submission, shall be filled by the bidder to bind the bidder to the contract. All the pages of the bid to documents shall be signed.

2.6.1.8 All Bids in which any of the prescribed conditions are not fulfilled or which have been vitiated by errors in calculations, totaling or other discrepancies or which contain tempering of BOQ(Financial Bid), may **BE LIABLE FOR REJECTION.**

2.7 Cost & Language of Bid

2.7.1.1 The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the procuring entity shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

2.7.1.2 The Bid, as well as all correspondence and documents relating to the Bid exchanged by the bidders and the procuring entity, shall be written only in English/ Hindi Language. Supporting

documents and printed literature that are part of the Bid may be in another language provided they are accompanied by an accurate translation of the relevant passages in English/ Hindi language, in which case, for purposes of interpretation of the Bid, such translation shall govern.

2.8 Alternative/ Multiple Bid

2.8.1.1 Alternative/ Multiple Bids shall not be considered at all.

2.9 Deadline for the submission of Bid

2.9.1.1 Bids shall be received, by the person, designated for the purpose, by the procuring entity or directly dropped in the bid box, at the place and up to the time and date specified in the NIB.

2.10 Late Bids

2.10.1.1 The person authorized to receive the bids shall not receive any bid that is submitted personally, after the time and date fixed for submission of bids.

2.10.1.2 Any bid, which arrives by post after the deadline for submission of bids, shall be declared and marked as "Late" and returned unopened to the Bidder.

2.11 Receipt and Custody of Bids

2.11.1.1 The bids shall be received by hand delivery, by courier or by post in the specified format up to the specified time and date and at the specified place, by the person authorized by the procuring entity.

2.11.1.2 All bids received unsealed, in torn or damaged condition through post or by personal delivery shall be so marked and signed on the cover by the person receiving the same and get signed on it by the person delivering it and put in a fresh cover and reseal, if so warranted. All such entries shall be attested by the receiving person.

2.11.1.3 The received bids shall be kept in safe custody in lock and key by the person authorized to receive the bids.

2.11.1.4 The location of bid box shall be such as to facilitate easy access to Bidders.

2.11.1.5 Bids received by the authorized person on or before the time and date fixed for receipt of bids shall be entered in bids receipt register and the same shall be closed at the scheduled time and date giving in words and figures the number of bids received up to the last time and date for submission of bids.

2.11.1.6 The record of bids received late through post shall be entered in bids receipt register after closing the register as per above.

2.11.1.7 Bids received by telegram or given on form other than the prescribed form shall not be considered.

2.12 Withdrawal, Substitution, and Modification of Bid

2.12.1.1 A Bidder may withdraw, substitute, or modify its bid after it has been submitted by sending a written Notice, duly signed by an authorized signatory, and shall include a copy of the authorization. The corresponding substitution or modification of the bid must accompany the respective written Notice. All Notices must be: -

- a. Submitted in accordance with the bidding document, and in addition, the respective envelopes shall be clearly marked "Withdrawal," "Substitution," "Modification"; and
- b. Received by the procuring entity prior to the deadline prescribed for submission of bids.

2.12.1.2 Bids requested to be withdrawn shall be returned unopened to the Bidders.

2.12.1.3 No bid shall be withdrawn, substituted, or modified in the interval between the deadline for submission of bids and the expiration of the period of the specified bid validity or any extension thereof.

2.13 Opening of Bid

- 2.13.1.1 The sealed bid box shall be opened by the bid opening committee constituted by the procuring entity at the time, date and place specified in the bidding document in the presence of the Bidders or their authorized representatives, who choose to be present. The bids receiving person shall also hand over all the bids received by him up to the time and date for submission of bids to the Convener of bids opening committee and obtain its signature in the bids receipt register.
- 2.13.1.2 The bid opening committee may co-opt experienced persons in the committee to conduct the process of bid opening.
- 2.13.1.3 The bids shall be opened by the bid opening committee in the presence of the Bidders or their authorized representatives who choose to be present. All envelopes containing bids shall be signed with date by the members of the committee in token of verification of the fact that they are sealed. The envelopes shall be numbered as a/n, where 'a' denotes the serial number at which the bid envelop has been taken for opening and 'n' denotes the total number of bids received by specified time.
- 2.13.1.4 The bid opening committee shall prepare a list of the Bidders or their representatives attending the opening of bids and obtain their signatures on the same. The list shall also contain the representative's name and telephone number and corresponding Bidders' names and addresses. The authority letters brought by the representatives shall be attached to the list. The list shall be signed by all the members of bid opening committee with date and time of opening of the bids.
- 2.13.1.5 Bids should always be placed in sealed envelope, in the manner detailed in Para 2.6 will be received and opened on the due dates by committee.
- 2.13.1.6 In case Envelope is not annexed with bid cost, EMD, etc. or not found in acceptable form, the bid documents will not be accepted at all and such illegible bids shall be returned on spot to the bidder or his representative during the process of opening of bids/ or by through post, as the case may be. The bid cost deposited for issue of bid documents/Demand Draft along with downloaded bid shall not be refunded, if bidder is found illegible.
- 2.13.1.7 After the opening of Envelope of eligible bidders, the bid documents containing terms & conditions, specifications and Bill of quantities (BoQ) etc. shall be evaluated by JMRC.
- 2.13.1.8 If it is found at any stage of bid evaluation after submission of bid that the bidder has made any correction/addition/alternation/omission in bid documents vis-a-vis bid documents available on the website/original draft NIB in office, the bid shall be treated as non-responsive and shall be



summarily rejected and the EMD deposited by bidder shall be forfeited in addition to any other action as per prevalent rules.

2.13.1.9 Envelope shall be opened at a time and the following details shall be read out and recorded:

- a. the name of the Bidder and whether there is a substitution or modification;
- b. the bid prices (per lot if applicable);
- c. Any other details as the committee may consider appropriate.

2.13.1.10 After all the bids have been opened, they shall be initialed and dated on the first page of the each bid by the members of the bid opening committee. All the pages of the price schedule and letters, Bill of Quantities attached shall be initialed and dated by the members of the committee. Key information such as prices, delivery period, etc. shall be encircled and unfilled spaces in the bids shall be marked and signed with date by the members of the committee. The original and additional copies of the bid shall be marked accordingly. Alterations/ corrections/ additions/ over-writings shall be initialed legibly to make it clear that such alteration, etc., were existing in the bid at the time of opening.

2.13.1.11 No bid shall be rejected at the time of bid opening except the late bids, alternative bids (if not permitted) and bids not accompanied with the proof of payment or instrument of the required price of bidding document, processing fee (if any) or user charges and Bid Security.

2.14 Selection Method

2.14.1.1 The selection method is Least Cost Based Selection (LCBS) i.e. Least bid price as detailed below:

2.14.1.1.1 Bid will be opened on scheduled time and date as per NIB.

2.14.1.1.2 The contract shall be awarded to most advantageous technically responsive bidder quoting least value of Total Cost incl. Taxes in financial bid BoQ (L1) subject to the fulfillment of Eligibility criteria mentioned in clause 16 of NIB.

2.14.1.1.3 The ranking of L1, L2, L3 etc, will be done on basis of Total Cost, with L1 being the bidder whose Total Cost is the lowest, L2 being the second lowest and so on.

2.14.1.1.4 In case, two or more responsive bidders have quoted the same price, which is also the lowest one rate offered, then all such bidders will be given an opportunity to revise their financial bid by submitting fresh financial bid, which shall necessarily be economical than the previous bid. The revised financial bid shall be submitted by the date and time as notified to the concerned bidders.

2.14.1.1.5 In case, two or more responsive bidders again quote the matching rates in their revised Financial Bids, then JMRC will resort to an open auction among the same Bidders (i.e. who have quoted the matching rates). Out of this open auction process, the bidders who offer the most economical shall be declared as successful bidders. The date and time of auction will be notified to the concerned Bidders.

2.14.1.1.6 Bidder shall quote price for each items and sub-items.

2.14.1.1.7 The purchase Order/work order shall be given to only One Bidder.

2.15 Clarification of Bids

- 2.15.1.1 To assist in the examination, evaluation, comparison and qualification of the Bids, the bid evaluation committee may, at its discretion, ask any Bidder for a clarification regarding its Bid. The committee's request for clarification and the response of the Bidder shall be in writing.
- 2.15.1.2 Any clarification submitted by a Bidder with regard to its Bid that is not in response to a request by the committee shall not be considered.
- 2.15.1.3 No change in the prices or substance of the Bid shall be sought, offered, or permitted, except to confirm the correction of arithmetic errors discovered by the committee in the evaluation of the financial Bids.
- 2.15.1.4 No substantive change to qualification information or to a submission, including changes aimed at making an unqualified Bidder, qualified or an unresponsive submission, responsive shall be sought, offered or permitted.
- 2.15.1.5 All communications generated under this rule shall be included in the record of the procurement proceedings.

2.16 Evaluation & Tabulation of Bids

2.16.1.1 Preliminary Examination of Bids

(i) Envelops containing bid documents will be opened first. Bids of those bidders who have not submitted bid documents/Bid Cost/Bid security shall be considered as non-responsive and liable to be rejected summarily.

(ii) Further the bid evaluation committee constituted by the procuring entity shall conduct a preliminary scrutiny of the opened bids to assess the prima-facie responsiveness and ensure that the:-

- a) Bid is submitted, sealed and signed, as per requirements listed in the bidding document;
- b) Bid is valid for the period, specified in the bidding document.
- c) Bid is unconditional and the Bidder has agreed to give the required performance security (if required) and;
- d) Other conditions, as specified in the bidding document are fulfilled.

2.16.1.2 Determination of Responsiveness

2.16.1.2.1 The bid evaluation committee shall determine the responsiveness of a Bid on the basis of bidding document and the provisions of pre-qualification/ eligibility criteria of the bidding document.

2.16.1.2.2 A responsive Bid is one that meets the requirements of the bidding document without any material deviation, reservation, or omission where: -

- i. "deviation" is a departure from the requirements specified in the bidding document;
- ii. "reservation" is the setting of limiting conditions or withholding from complete acceptance of the requirements specified in the bidding document; and
- iii. "Omission" is the failure to submit part or all of the information or documentation required in the bidding document.

- 2.16.1.2.3 A material deviation, reservation, or omission is one that,
- i. if accepted, shall:-
 1. affect in any substantial way the scope, quality, or performance of the subject matter of procurement specified in the bidding documents; or
 2. limits in any substantial way, inconsistent with the bidding documents, the procuring entity's rights or the Bidder's obligations under the proposed contract; or
 - ii. If rectified, shall unfairly affect the competitive position of other Bidders presenting responsive Bids.
- 2.16.1.2.4 The bid evaluation committee shall examine the technical aspects of the Bid in particular, to confirm that all requirements of bidding document have been met without any material deviation, reservation or omission.
- 2.16.1.2.5 The procuring entity shall regard a Bid as responsive if it conforms to all requirements set out in the bidding document, or it contains minor deviations that do not materially alter or depart from the characteristics, terms, conditions and other requirements set out in the bidding document, or if it contains errors or oversights that can be corrected without touching on the substance of the Bid.
- 2.16.1.3 Non-material Non-conformities in Bids**
- 2.16.1.3.1 The bid evaluation committee may waive any non-conformity in the Bid that does not constitute a material deviation, reservation or omission, the Bid shall be deemed to be substantially responsive.
- 2.16.1.3.2 The bid evaluation committee may request the Bidder to submit the necessary information or document like GST certificate, Pan Certificate, etc. within a reasonable period of time. Failure of the Bidder to comply with the request may result in the rejection of its Bid.
- 2.16.1.3.3 The bid evaluation committee may rectify non-material nonconformities or omissions on the basis of the information or documentation received from the Bidder under above.
- 2.16.1.3.4 Bids shall be evaluated based on the documents submitted as a part of bid. Bidders are expected to quote for all the items. Similarly, in case the proposal of a Bidder is non-responsive for any item, the Bidder shall be summarily rejected.
- 2.16.1.3.5 The evaluation shall include all costs and all taxes and duties applicable to the Bidder as per law of the Central/ State Government/ Local Authorities, and the evaluation criteria specified in the bidding documents shall only be applied;
- 2.16.1.3.6 The offers shall be evaluated and marked L1, L2, L3 etc. L1 being the lowest offer quoting least value of "Total Cost" in financial bid. A list of L1, L2....will be prepared accordingly.
- 2.16.1.3.7 The rates quoted by L1 Bidder shall be accepted as the bid rates for each item.
- 2.16.1.3.8 The members of bid evaluation committee shall give their recommendations below the table regarding lowest bid or most advantageous bid and sign it.

2.17 Correction of Arithmetic Errors in Financial Bids:

2.17.1.1 The bid evaluation committee shall correct arithmetical errors in substantially responsive Bids, on the following basis, namely: -

2.17.1.2 If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the bid evaluation committee there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;

2.17.1.3 If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and if there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to clause (2.17.1.2) and above.

2.18 Price/ purchase preference in evaluation:

2.18.1.1 Price and/ or purchase preference notified by the State Government (GoR) and as mentioned in the bidding document shall be considered in the evaluation of Bids and award of contract.

2.19 Negotiations

2.19.1.1 Negotiations may, however, be undertaken with the lowest Bidder when the rates of any job type are considered to be much higher than the prevailing market rates or the rates quoted for that job type by other bidders.

2.19.1.2 The bid evaluation committee shall have full powers to undertake negotiations. Detailed reasons and results of negotiations shall be recorded in the proceedings.

2.19.1.3 The lowest Bidder shall be informed in writing either through messenger or by registered letter and e-mail (if available). A minimum time shall be given for calling negotiations. In case of urgency the bid evaluation committee, after recording reasons, may reduce the time, provided the lowest or most advantageous Bidder has received the intimation and consented to regarding holding of negotiations.

2.19.1.4 Negotiations shall not make the original offer made by the Bidder inoperative. The bid evaluation committee shall have option to consider the original offer in case the Bidder decides to increase rates originally quoted or imposes any new terms or conditions.

2.19.1.5 In case of non-satisfactory achievement of rates from lowest Bidder, the bid evaluation committee may choose to make a written counter offer to the lowest Bidder and if this is not accepted by him, the committee may decide to reject and re-invite Bids or to make the same counter-offer first to the second lowest or most advantageous Bidder, then to the third lowest or most advantageous Bidder and so on in the order of their initial standing and work/ supply order be awarded to the Bidder who accepts the counter-offer. This procedure would be used in exceptional cases only.



- 2.19.1.6 In case the rates even after the negotiations are considered very high, Tender may be annulled and fresh Bids invited.

2.20 Acceptance of the successful Bid and Issuance of Purchase Order

- 2.20.1.1 The procuring entity after considering the recommendations of the bid evaluation committee and the conditions of Bid, if any, financial implications, trials, sample testing and test reports, etc., shall accept or reject the successful Bid. If any member of the bid evaluation committee has disagreed or given its note of dissent, the matter shall be referred to the next higher authority, as per delegation of financial powers, for decision.
- 2.20.1.2 Decision on Bids shall be taken within original validity period of Bids and time period allowed to procuring entity for taking decision. If the decision is not taken within the original validity period OR time limit allowed for taking decision, the matter shall be referred to the next higher authority in delegation of financial powers for decision.
- 2.20.1.3 Before issuance of purchase order the procuring entity shall ensure that the price of successful Bid is reasonable and consistent with the required quality.
- 2.20.1.4 A Bid shall be treated as successful only after the competent authority has approved the procurement in terms of that Bid.
- 2.20.1.5 The Bid Security of the Bidders who's Bids could not be accepted shall be refunded soon after the contract with the successful Bidder is signed and its performance security is obtained, if applicable.
- 2.20.1.6 Bidder has to execute agreement as per 6.13 of Bid document, Form J: Form of agreement within seven days of acceptance of Purchase order/LOA.

2.21 Procuring entity's right to accept or reject any or all Bids

- 2.21.1.1.1 The Procuring entity reserves the right to accept or reject any Bid, and to annul (cancel) the bidding process and reject all Bids at any time prior to award of contract, without thereby incurring any liability to the Bidders as per RPPP Act and Rules.

2.22 Performance Security Deposit

- 2.22.1 Prior to execution of work order, Performance security shall be solicited from all successful Bidder except the departments of the State Government and undertakings, corporations, autonomous bodies, registered societies, co-operative societies which are owned or controlled or managed by the State Government and undertakings of the Central Government. However, a performance security declaration shall be taken from them. The State Government may relax the provision of performance security in particular procurement or any class of procurement.
- 2.22.2 The amount of performance security shall be as per mentioned in NIB in Bid Document. The Performance Security may be deducted from running bill/final bill on request by contractor in writing and approval by competent authority.
- 2.22.3 Performance Security will be discharged after completion of bidder's performance obligations including warranty obligations under the contract.
- 2.22.4 If the bidder fails or neglects any of his obligations under the contract, JMRC reserve the right to forfeit performance security furnished by the bidder as penalty for such failure.
- 2.22.5 Performance security shall be furnished in any one of the following forms: -
- Bank Draft or Banker's Cheque of a scheduled bank;
 - Bank guarantee/s of a scheduled bank. It shall be got verified from the issuing bank. Other conditions regarding bank guarantee shall be same as mentioned in the bidding document for Bid Security, if applicable.
 - Fixed Deposit Receipt (FDR) of a scheduled bank. It shall be in the name of procuring entity on account of Bidder and discharged by the Bidder in advance. The procuring entity shall ensure before accepting the FDR that the Bidder furnishes an undertaking from the bank to make payment/ premature payment of the FDR on demand to the procuring entity without requirement of consent of the Bidder concerned. In the event of forfeiture of the performance security, the Fixed Deposit shall be forfeited along with interest earned on such Fixed Deposit.
- 2.22.6 Performance security furnished in the form specified in clause 2.23.1.5 [b.] to [c] above shall remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the Bidder, including warranty obligations and maintenance and defect liability period.
- 2.22.7 Forfeiture of Performance Security: Security amount in full or part may be forfeited, including interest, if any, in the following cases:-
- When any terms and condition of the contract is breached.
 - When the Bidder fails to make complete supply/service satisfactorily.
 - If the Bidder breaches any provision of code of integrity, prescribed for Bidders, specified in the bidding document.
- 2.22.8 Notice will be given to the Bidder with reasonable time before Performance Security deposited is forfeited.
- 2.22.9 No interest shall be payable on the Performance Security Deposit.
- 2.22.10 **Additional Performance Security.-** (1) In addition to Performance Security as specified in rule 75, an Additional Performance Security shall also be taken from the successful bidder in case

of unbalanced bid. The Additional Performance Security shall be equal to fifty percent of Unbalanced Bid Amount. The Additional Performance Security shall be deposited in lump sum by the successful bidder before execution of Agreement. The Additional Performance Security shall be deposited through e-Grass, Demand Draft, Banker's Cheque, Government Securities or Bank Guarantee.

(2) The Additional Performance Security shall be refunded to the contractor after satisfactory completion of the entire work. The Additional Performance Security shall be forfeited by the Procuring Entity when work is not completed within stipulated period by the contractor. Provision for 'Unbalanced Bid' and 'Additional Performance Security' shall be mentioned in the Bidding Documents by the Procuring Entity."

3.0 General Conditions of Contract

3.1 Terms & Conditions

3.1.1 Contract Documents:

3.1.1.1 Subject to the order of precedence set forth in the Agreement, all documents forming the Contract (and all parts thereof) are intended to be correlative, complementary, and mutually explanatory.

3.1.2 Scope of Supply

3.1.2.1 Subject to the provisions in the bidding document and contract, the goods and related services to be supplied shall be as specified in the Letter of acceptance.

3.1.3 Delivery

3.1.3.1 Subject to the conditions of the contract, the goods/items should be delivered within the time period mentioned in the LOA or earlier.

3.1.3.2 If national holiday is being declared on bid due date then bid will be opened on next suitable working day.

3.1.3.3 The Contractor shall arrange supplies within the stipulated time period.

3.1.3.4 Bidders shall be asked to supply the items as per specification within the specified delivery/ completion period at designated places within Jaipur and across the State of Rajasthan and the details of supply/ shipping and exact locations where the items need to be supplied shall be specified in the purchase order and/ or contract.

3.1.3.5 The Supplier/ Selected Bidder shall arrange to supply and arrange service at site of the ordered materials as per specifications in bid document.

3.1.4 Recoveries from Supplier/ Contractor

3.1.4.1 Recovery of liquidated damages, short supply, defects in, rejected shall be made ordinarily from bills or Performance Security Deposit (as the case may be).

3.1.4.2 The Purchase Officer shall withhold amount to the extent of short supply, broken/ damaged or for rejected and in case of failure in satisfactory replacement by the supplier along with amount of liquidated damages shall be recovered from his dues and Bid Security available with the department.

- 3.1.4.3 The balance, if any, shall be demanded from the Supplier/ Contractor and when recovery is not possible, the Purchase Officer shall take recourse to law in force.

3.1.5 Specifications and Standards

3.1.5.1 Technical Specifications and Drawings

- a. The Supplier/ Contractor shall ensure that the goods/items and related services comply with the technical specifications and other provisions of the Contract.
- b. The Supplier/ Contractor shall be entitled to disclaim responsibility for any design, data, drawing, specification or other document, or any modification thereof provided or designed by or on behalf of the Purchaser, by giving a notice of such disclaimer to the Purchaser.
- c. The goods and related services supplied under the Contract for execution of work order shall conform to the standards mentioned in work order and, when no applicable standard is mentioned, the standard shall be equivalent or superior to the official standards whose application is appropriate to the country of origin of the Goods.

- 3.1.5.2 Wherever references are made in the Contract to codes and standards in accordance with which it shall be executed, the edition or the revised version of such codes and standards shall be those specified in the work order. During Contract execution, any changes in any such codes and standards shall be applied only after approval by the Purchaser and shall be treated in accordance with the general conditions of the contract.

3.1.6 Inspection

- 3.1.6.1 The Purchase Officer or his duly authorized representative shall at all reasonable time have access to the supplier's/ Contractor's premises and shall have the power at all reasonable time to inspect and examine the materials and workmanship of the goods/ equipment/ machineries during manufacturing process or afterwards as may be decided.

3.1.7 Rejection

- 3.1.7.1 Articles not approved during inspection or testing shall be rejected and will have to be replaced by the Contractor at his own cost within the time fixed by the Purchase Officer.
- 3.1.7.2 If, however, due to exigencies of work, such replacement either in whole or in part, is not considered feasible, the Purchase Officer after giving an opportunity to the Contractor of being heard shall for reasons to be recorded, deduct a suitable amount from the approved rates. The deduction so made shall be final.
- 3.1.7.3 The rejected articles shall be removed by the supplier/ Bidder/ Contractor within 15 Days of intimation of rejection, after which Purchase Officer shall not be responsible for any loss, shortage or damage and shall have the right to dispose of such articles as he thinks fit, at the Contractor's risk and on his account.

3.1.8 Liquidated Damages (LD)

- 3.1.8.1 In case of extension in the delivery period with liquidated damages the recovery shall be made on the basis of following percentages of value of Purchase order with the Bidder has failed to supply/ install/ complete/service (whichever is applicable):-

- 3.1.8.2 delay up to one fourth period of the prescribed delivery period: 2.5%
- 3.1.8.3 delay exceeding one fourth but not exceeding half of the prescribed period: 5.0%
- 3.1.8.4 delay exceeding half but not exceeding three fourth of the prescribed period: 7.5%
- 3.1.8.5 delay exceeding three fourth of the prescribed period: 10%
- 3.1.8.6 Fraction of a day in reckoning period of delay in supplies shall be eliminated if it is less than half a day.
- 3.1.8.7 The maximum amount of liquidated damages shall be 10% of the contract value.
- 3.1.8.8 If the supplier requires an extension of time in completion of contractual supply on account of occurrence of any hindrance, he shall apply in writing to the authority, which has placed the supply order, for the same immediately on occurrence of the hindrance but not after the stipulated date of completion of supply.
- 3.1.8.9 Delivery period may be extended with or without liquidated damages if the delay in the supply of goods is on account of hindrances beyond the control of the Bidder.

3.1.9 Termination

3.1.9.1 Termination for Default

- 3.1.9.1.1 The bid sanctioning authority of JMRC may, without prejudice to any other remedy for breach of contract, by a written notice of default of at least 30 days sent to the supplier/ Contractor, terminate the contract in whole or in part: -
 - a. If the supplier/ Contractor fails to deliver any or all quantities of the service within the time period specified in the contract, or any extension thereof granted by JMRC;
 - or
 - b. If the supplier/ Contractor fails to perform any other obligation under the contract within the specified period of delivery of service or any extension granted thereof;
 - or
 - c. If the supplier/ Contractor, in the judgment of the Purchaser, is found to be engaged in corrupt, fraudulent, collusive, or coercive practices in competing for or in executing the contract.
 - d. If the supplier/ Contractor commits breach of any condition of the contract.
- 3.1.9.2 If JMRC terminates the contract in whole or in part, amount of Performance Security Deposit may be forfeited.

Note: In addition to the conditions specified above, the provision of JMRC General Condition of Contract (GCC) is applicable. GCC document is available on the JMRC website. The successful bidder shall submit a declaration for acceptance of the terms and conditions mentioned in the JMRC GCC {clause 6.6 Form F (j)}.

4.0 SPECIAL TERMS AND CONDITIONS OF TENDER & CONTRACT

4.1 Bidders to Bid for all Items

- 4.1.1.1 Bidders must quote for all the items mentioned in the BOQ (Bill of Quantities). In case, a Bidder does not quote for any item, the bid shall be summarily rejected.

4.2 Payment Terms and Penalty

- 4.2.1.1 Advance Payment will not be made.
- 4.2.1.2 Unless otherwise agreed between the parties, payment for the delivery of the stores will be made on submission of bill in proper form by the Bidder to the Purchase Officer in accordance with contract all remittance charges will be borne by the Bidder.
- 4.2.1.3 In case of disputed items, 10% to 25% of the amount shall be withheld and will be paid on settlement of the dispute.
- 4.2.1.4 Payment in case of those goods which need testing shall be made only when such tests have been carried out, test results received conforming to the prescribed specification
- 4.2.1.5 Payment schedule: Payments to the Contractor, after successful completion of the specified deliverables & related services as per PO, would be made as under: -

- 4.2.1.6 Due payments shall be made promptly by the purchaser after submission of an invoice or request for payment by the supplier/ Contractor, and the purchaser has accepted it.
- 4.2.1.7 The currency or currencies in which payments shall be made to the supplier/ Contractor under this Contract shall be Indian Rupees (INR) only.
- 4.2.1.8 All remittance charges will be borne by the supplier/ Contractor.
- 4.2.1.9 In case of disputed items, the disputed amount shall be withheld and will be paid only after settlement of the dispute.
- 4.2.1.10 Payment in case of those goods which need testing shall be made only when such tests have been carried out, test results received conforming to the prescribed specification.

4.3 Warranty

- 4.3.1.1 For minimum warranty period refer Section 5 clause 5.1 i.e. Technical Specifications and Standards of bid document.
- 4.3.1.2 JMRC shall evaluate performance of bidder firm after completion of Warranty period and may decide to deduct/fortify PBG amount, for every loss in JMRC, due to failure on part of bidder firm to provide effective warranty at site.

4.4 Other Special Terms

- 4.3.1 Bidders are advised to carry out extensive survey and site visit and analysis at their own cost, before submitting the bid as per JMRC extent procedures and permission.
- 4.3.2 Contractor shall be responsible for insurance and safety of the labor involved in executing the scope of work of this BID.
- 4.3.3 The contractor shall make sure that no harm or damage is made to JMRC property and assets while executing the scope of work of this BID. The performance security/payment shall be forfeited or shall be refunded/ made only after making the adjustments for any such damage made by the contractor and his staff.
- 4.3.4 In case the Bidder fails to supply the final deliverables within stated timelines, the LD as per clause "liquidated damage" would be applicable.
- 4.3.5 In case of any errors/ inaccuracies remain in supply and services even after the final approval of design from the purchaser then the Contractor has to take corrective actions on Bidders part (including all related expenditure on any such measures). In such cases, due to delay in delivery schedule, the LD as per clause "liquidated damage" would be applicable.

4.5 VARIATION

- 4.5.1 Right to vary Quantity will be governed as per Rule 73 of RTPPR, 2013.
- 4.5.2 If the procuring entity does not procure any subject matter of procurement or procures less than the quantity specified in the bidding documents due to change in circumstances, the bidder shall not be entitled for any claim or compensation except otherwise provided in the bidding documents.
- 4.5.3 Repeat orders for extra items or additional quantities may be placed on the rates and conditions given in the contract. Delivery or completion period may also be proportionately increased. The limits of repeat order shall be as under-
 - (a) 50% of the quantity of the individual items and 50% of the value of original contract in case of works; and
 - (b) 50% of the value of goods or services of the original contract.


