1. Required material should be strictly as per descriptions mentioned as below:

S.no.	Specification of Pigeon net
1.	Mesh size: 25 mm,
2.	Mash shape : square
3.	Color of net: white/off white
4.	Material: Nylon HDPE,15ply
5.	Installation of pigeon net should be done by bidder.
6.	Drilling/Hooks or fixing of net on structure should be done at 1 to 1.5 feet max.

2. Offer from the firms who do not have a valid GST No. will not be entertained. GST No. Should be clearly indicated in offer and Enclose Copy of GST Registration Certificate.
3. Order will be given to one firm, based on overall lowest rates of item.
4. The above material shall be delivered at Custody Store Section, Room no. D20, Train maintenance Depot, Bhrihu Path, Mansarovar –Jaipur-302020 to JE/Custody Store, Cont. no. 07728895713.
5. The rates quoted shall be For JMRC office, Mansarovar Metro Depot, Jaipur-302020, inclusive of all expenses i.e. all taxes, and transportation charges etc; no other charges shall be paid by JMRC. GST will be paid at rate applicable at the time of billing.
6. **Delivery Period:** The material is to be supplied within 08 weeks or as soon as possible from date of issue of purchase order.
7. **Liquidated Damages:**
- i.) If the contractor requires an extension of time on completion of contractual supply on account of occurrence of any hindrance he shall apply in writing for extension on occurrence of hindrance.
- ii.) The Purchase Officer may extend the delivery period with or without liquidated damages in case they are satisfied that the delay in the supply of goods is on account of hindrances. Reasons shall be recorded.
- iii.) Extension in delivery period: In case of extension in the delivery period with liquidated damages the recovery shall be made on the basis of following percentages of value of stores which the tenderer has failed to supply :-

- a. Delay upto one fourth period of the prescribed delivery period - 2.5%.
- b. Delay exceeding one fourth but not exceeding half of the prescribed delivery period - 5%.
- c. Delay exceeding half but not exceeding three fourth of the prescribed delivery period - 7.5%.
- d. Delay exceeding three fourth of the prescribed delivery period - 10%.

Note: Fraction of a day in reckoning period of delay in supplies shall be eliminated if it is less than half a day. The maximum amount of liquidated damages shall be 10%.

8. **Warranty:** Warranty shall be 24 months from the date of supply or 18 months from the date of acceptance, whichever is earlier.
9. The quantity of material may increase/decrease up to a certain limit (up to 25%) as per requirements.
10. Bidder name, Bid no, due date & time should be also be mentioned on the sealed offer.
11. **Payment Terms-**100% payment after receipt and acceptance of material.
12. **Inspection Authority:** By JMRC representative.
13. **Testing and suitability condition:**
 - a.) Pigeon, sparrow, bird etc. should not enter inside of net after installation of pigeon net.
 - b.) Performance of above items will be monitored for duration of 15 days and thereafter technical suitability will be given.
 - c.) **Other conditions:**
 - i.) Bidder may visit at Mansarovar metro depot for actual requirement.
 - ii.) It is responsibility of bidder to arrange any equipment to work at height (approx. 60feet) (like crane, lifter, ladder etc.).
 - iii.) It is necessary for the worker during work in workshop/depot always use personal protective equipment (helmet, safety belt etc.). PPE will be arranged by bidder.
