9.	As total contract value i.e. 7.85 cr. For 2 years span hence requirement of 1 work/2 work/3 works of 80%, 50%, 40% value respectively on the same basis is not justified here. As per standard practice being followed n majority of tenders requirement value is calculated on the basis of one year estimated value of contract. We hereby request that kindly revise this requirement on the basis of One year contract value.	
10.	As per this clause all consumables are to be top up on consumption whereas on page no 93 (Consumables table) quantities are fixed for each station monthly basis. Both these clauses are contradictory as amounts. It is requested that kindly freeze these quantities considering all aspects to avoid any discrepancies during work execution.
