

Ref.: (1) Your Bid as above opened on 23.09.2024. (Technical cum financial)

With reference to above, your bid is hereby accepted for above said work at your quoted amount of Rs. 7,08,000/- (Rupees Seven Lakh and Eight Thousand only) as per BOQ attached herewith against the estimated cost of Rs. 7,04,460/- incl. all taxes. The accepted rate/cost is inclusive of all taxes, duties and other levies, material, labor and GST etc. The award is subject to the following conditions:

1. Signing of Contract Agreement and Submission of Performance Security

- 1.1 Within 15 days from the date of issue of Letter of Acceptance, you will be required to execute the Contract Agreement on non-Judicial Stamp papers as per Stamps Duty Act, Rajasthan.
- 1.2 It may please be noted that until a contract agreement is executed, this letter will constitute a binding contract between you and JMRC.
- 1.3 Prior to signing of the Contract Agreement, you shall submit performance security of 5% of contract value (incl. GST) i.e. Rs.35,400/- vide clause no. 2.23 of bid document and also as per Clause 75 of RTPPR 2013 within 10 days of receipt of this LOA.
- 1.4 The performance security shall be in form of 1. Bank Draft or Banker's Cheque or, 2. Bank guarantee/s of a scheduled bank in favour of Jaipur Metro Rail Corporation Ltd or 3. Fixed Deposit Receipt (FDR), which should be valid for 60 days beyond the date of completion of all contractual obligations of the bidder, including warranty obligations and maintenance and defect liability period. Government of Rajasthan amended the Rajasthan Stamp Act 1998 vide Finance Bill 2015 and inserted Article 13-A which provides that bank guarantee executed by a bank as a surety to secure the due performance of a contract or due discharge of a liability for this stamp duty is payable @0.25 percent of the amount secured subject to maximum of Rupees 25000/-. Format of Bank Guarantee for Performance Security attached herewith as Annexure B.

2. Scope of Work:

- 2.1 Scope of work must be governed as per Section 5 of BID Document and BOQ (Bill of Quantities) attached herewith LOA.
- 2.2 The work shall be executed with proper coordination with nominated JMRC Authorities.
- 2.3 Contractor must ensure proper safety during work execution. Safety shoes, hand gloves etc. shall be arranged by the contractor to their workers to avoid any accident. JMRC will not be responsible for any accident/casualty during the work execution and it will be solely the responsibility of the contractor.
- 2.4 Spares, tools and equipment, accessories, ladders, labour, duties, taxes, octroi, rentals etc. will be arranged by Contractor. JMRC will not pay extra for it.

2.5 Engineer In-charge for the work shall be DGM (Tr./E&M).

3. Time period for Work Completion:

3.1 The work shall be executed within **Two months** from the date of issue of this Letter of Acceptance (LOA) or earlier.

4. Payment Terms and Penalty:

- 4.1 Payment terms and penalty will be as per clause 4.2 of section 4 of bid document.
- 4.2 No price variation shall be their during the agreement period/extended period of agreement.
- 4.3 Contract price shall be inclusive of all taxes, duties, royalties etc. Nothing shall be extra payable over the accepted rates.
- 4.4 In case the contractor fails to supply the final deliverables within stated timelines, the LD as per clause 3.1.8 "liquidated damage" of bid document would be applicable.

5. Warranty:

- 5.1 Minimum warranty period/DLP period will be One year from the date of completion of work. The warranty of the supplied items shall be for minimum 01 Year from the date of successful commissioning of the work. All the goods or material shall be supplied strictly in accordance with the specifications and standards as mentioned in this bid document.
- 5.2 JMRC shall evaluate performance of bidder firm after completion of Warranty period and may decide to deduct/fortify PBG amount, for every loss in JMRC, due to failure on part of bidder firm to provide effective warranty at site.

6. Unconditional Acceptance:

This Letter of Acceptance (LOA) along with Bill of Quantities is being sent to you in duplicate. You are requested to return a copy signed by Authorized signatory on each page endorsing "unconditional acceptance" thereof so as to reach under signed within 10 working days from the receipt of this LOA. It may please be noted that until a formal agreement is executed, this letter will constitute a binding contract between you and JMRC.

- 7. Scope of Work, duration of contract, payment terms & schedule, Special Terms and conditions of Bid & contract (General) etc. and all other terms and conditions shall be as per bid document duly signed by you. The work shall be executed as per terms and conditions, scope of work and technical specifications mentioned in bid document.
- **8.** Bid document is part of this LOA. This LOA is under RTPP Act & Rules.

The Bank shall pay to the Employer any money so demanded notwithstanding any dispute/disputes raised by the Contractor in any suit or proceedings pending before any Court, Tribunal or Arbitrator/s relating thereto and the liability under this guarantee shall be absolute and unequivocal.
