basis of following percentages of value of stores which the tenderer has failed to supply :-

- (a) Delay upto one fourth period of the prescribed delivery period 2.5%.
- (b) Delay exceeding one fourth but not exceeding half of the prescribed delivery period 5%.
- (c) Delay exceeding half but not exceeding three fourth of the prescribed delivery period 7.5%.
- (d) Delay exceeding three fourth of the prescribed delivery period 10%. Note: Fraction of a day in reckoning period of delay in supplies shall be eliminated if it is less than half a day. The maximum amount of liquidated damages shall be 10%.
- 12. The quantity of material may increase/decrease up to a certain limit (up to 25%) as per requirements.
- 13. Bidder name, Bid no, due date & time should be also be mentioned on the sealed offer.
- 14. Payment Terms-100% payment after receipt and acceptance of material.
- 15. Inspection Authority: By JMRC representative.
- 16. JMRC reserves the right to accept or reject any offer in whole or part without assigning any reason.
- 17. Validity of offer: Bidder is required to keep their offer open at least ninety days (90 days) from the date of bid opening.
- The offer shall be unconditional and duly signed; Conditional offer will be summarily rejected.
