NOTICE INVITING BID (NIB)

1 General

1.1 Name of Work

Jaipur Metro Rail Corporation Ltd. (JMRC) invites Single tender in physical form from authorised representative of Original Equipment Manufacturer i.e. M/s Alstom Transport India Ltd for the work "Comprehensive Annual Maintenance Contract (CAMC) for Signalling and Train Control (S&TC) System of Phase- 1A & 1B for 10 years."
