

## 1. NOTICE INVITING BIDS

- 1.1 Jaipur Metro Rail Corporation (JMRC) Ltd. invites Bids (Single stage two envelope method) "Comprehensive Annual Maintenance Contract of X-ray baggage scanner machines and DFMD's of phase-1B for Three Years in JMRC." through e-tendering process i.e. by online tendering process.

Unsigned Bids will not be entertained and will be rejected outright.

## 20. Minimum Eligibility Criteria:

- **A.** Bidder should have valid GST registration certificate issued by competent authority and shall enclose GST certificate along with bid.
- **B.** Applicant should have valid PAN certificate/ card issued by the Income Tax Dept. of GOI and enclose PAN certificate along with bid.
- C. Bidder should be OEM or OEMs Authorized dealer of X-Ray baggage scanner or DFMD. Bidder shall submit the OEM certificate. In case of authorized dealers:-Bidder is required to submit letter of authorization from OEM for participation in tender. During currency of contract along with undertaking as per clause 6.12 form:- J, Form of authorization from OEM for dealer(Undertaking). This undertaking is mandatory to submit in original on Rs. 100/- Non judicial stamp paper duty verified by Notary at the time of bid submission i.e. along with financial instruments (Bid cost, Bid security, Bid processing fees)

OR

The bidder firm should have satisfactorily completed similar works during last five financial years and the period ending last day of month previous to the one in which the Bids are invited in current financial year should be either of the following:

Three similar completed contracts each of contract value not less than 40% of estimated cost i.e. Rs. 570,935/-.

OF

Two similar completed contracts each of contract value not less than 50% of estimated cost i.e. Rs. 713,669/-.

<u>OR</u>

One similar completed contracts each of contract value not less than 80% of estimated cost i.e. Rs. 1,141,870/-.
