

Special Terms and Conditions:-

- Required Testing/Certification should be strictly as per scope of work as below:
 - a.) Testing & certification of Pressure Vessels (Air Reservoirs):

 All Pressure Vessels / Reservoirs (Annexure-B1 attached) to be as per item no. 31 of factory & boiler act Rajasthan and certificate of the same to be issued for each individual items separately. Testing also includes through internal examination for surface defects like fittings, grooving, corrosion etc.
- b.)Testing & certification of EOT Cranes:

 All EOT cranes, (Annexure-B2 attached) to be tested as per item no.

 29 of factory & boiler act Rajasthan and certificate of the same to be

issued for each individual item separately.

- c.) Testing & certification of Lifting Tackles & Slings:

 All lifting Tackels and slings (Annexure-B3 attached) to be tested as per item no 29 of factory & boiler act Rajasthan and certificate of the same to be issued for each individual item separately.
- 2. Offer from the firms who do not have a valid GST No. will not be entertained. GST No. Should be clearly indicated in offer and Enclose Copy of GST Registration Certificate.
- **3.** Bidder must enclose a valid copy of approval and certificate from factory & boiler act Rajasthan for safety certification.
- **4.** Order will be given to one firm, based on overall quoted lowest rates of item in BOQ.

5. Performance Security Deposit:

- i.) The successful Bidder shall submit a Performance Security Deposit equal to 5% of LOA/PO, in the form of Bankers Cheque/Demand draft/FDR or Bank Guarantee from any scheduled bank in favour of Jaipur Metro Rail Corporation Ltd within 60 days from the date of issue of LOA/PO in case of procurement of goods and services. In case of deposition of performance security in form of bank guarantee, then the Bank Guarantee will be executed on stamp paper (of any state) of 0.25% of Bank guarantee amount.
- ii.) Amount to be paid of performance security will be informed to successful bidder at the time of Purchase order/LOA.
- iii.) Performance security shall be valid for a period of 60 days beyond the completion of all contractual obligations.

- a. When any terms and condition of the contract/RFQ is breached.
- b. When the Bidder fails to complete the work supply satisfactorily.
 - c. If the Bidder breaches any provision of code of integrity, prescribed for Bidders, specified in the RFQ document.
 - v.) Notice will be given to the Bidder with reasonable time before Performance Security deposited is forfeited.
 - vi.) No interest shall be payable on the Performance Security Deposit.

6. SIGNING OF AGREEMENT:

Successful bidder shall prepare the Agreement on non-judicial stamp as per stamp act, duly incorporating all the terms of agreement between the two parties. Within 60 days from the date of issue of the LOA/PO, the successful bidder will be required to execute the Contract Agreement.

7. The Testing of pressure vessels, EOT Cranes & lifting tackles will be done at Train maintenance Depot, Bhrigu Path, Mansarovar –Jaipur-302020 to JE/Custody Store, Cont. no. 07728895713.

8. Terms and conditions for Testing:

- i.) The contractor conducting tests and certification should be authorized by the Chief Inspector of Factories & Boiler, Jaipur. The testing agency should attach copy of authorization with the RFQ otherwise RFQ will not be accepted.
- ii.) All Inspection & Testing shall be carried out as per guideline of Factory & Boiler Act Rajasthan.
- iii.) Work shall be started within 30 days from date of issue of LOA/PO and finished at the earliest or max 15 days.
- iv.) All tools, equipment, machinery, labour required for this testing work will be arranged by the contractor itself & contractor has to issue a certificate for testing.
- v.) Successful Contractor will be permitted to bring all labour and materials, tools & equipment etc. in the JMRC Workshop, Jaipur during contract period.
- vi.) Any defect found during testing, JE/MWT will rectify the same after intimated by contractor, then contractor will be bound to testing again these items within 07 days and no extra payment will be made for this activity.
- vii.) After each testing, certificate will be issued by contractor as per annexure B1, B2, B3 for each items.
- viii.) Any re-work if required shall be done by the contractor at his own cost.
- ix.) The supervision, inspection and maintain of records of the said work will be done by JE/MWT and JE/Custody Store.
- x.) The contractor shall bear the cost of repair of Rolling Stock and other government properties damaged due to higher hot verified in

workmen. He also liable to pay the cost of the repair etc. The cost of damage will be solely assessed by the Metro Administration and it will not be disputed by the contractor.

xi.) The contractor should ensure the safety norms required to take care of during working for several work electrical current, in Workshop and especially at elevated height preventative care should always be taken for electrical current, fire (inflammable items) etc. The contractor will himself ensure the safety of his workers and provide all required safety item.

9.The rates quoted shall be For JMRC office, Mansarovar Metro Depot, Jaipur-302020, inclusive of all expenses i.e. all taxes, and transportation charges etc; no other charges shall be paid by JMRC.GST will be paid at rate applicable at the time of billing.

10. Delivery Period: Not applicable.

11. Liquidated Damages:

- i.) If the contractor requires an extension of time for completion of work on account of occurrence of any natural hindrance he shall apply in writing for extension on occurrence of hindrance.
- ii.) The Purchase Officer may extend the timeline with or without liquidated damages in case they are satisfied that the delay in the work execution/work completion is on account of hindrances. Reasons shall be recorded.
- iii.) Extension in work completion: In case of extension in the work completion with liquidated damages the recovery shall be made on the basis of following percentages of value of stores which the tenderer has failed to supply:
 - a. Delay upto one fourth period of the prescribed period 2.5%.
- b. Delay exceeding one fourth but not exceeding half of the prescribed period 5%.
- c. Delay exceeding half but not exceeding three fourth of the prescribed period 7.5%.
 - d. Delay exceeding three fourth of the prescribed period 10%.

Note: Fraction of a day in reckoning period of delay in work completion shall be eliminated if it is less than half a day. The maximum amount of liquidated damages shall be 10%.
