#### 4. Auction Procedure:

- i. Bidder shall submit duly signed (on each page) copy of this document.
- ii. Bidders shall submit Earnest Money of Rs. 2548/- (Rupees Two Thousand Forty Eight Only) at time of auction. The Earnest Money may be given in the form of a banker's cheque or demand draft of a scheduled bank in favour of "**Jaipur Metro Rail Corporation Limited**" Payable at Jaipur.
- iii. Bidder will have to start bidding, from Bid Start Price (BSP) and subsequent bids can be submitted in the incremental value of Rs. 1000 for all items.
- iv. Ordinarily, the highest bidder on the fall of the hammer/ up to 3 announcements will be considered as the purchaser, unless the bid is lower than any reserve price that has been fixed or the sale is subject to the approval of higher authority.
- v. Earnest Money of all unsuccessful bidders shall be returned at the end of auction under their receipt.
- vi. JMRC may cancel the auction any time due to any reason whatsoever. In such case, Earnest Money of all the bidders shall be returned.

#### 5. Terms and Conditions:

- i. Bidders will have to inspect the material thoroughly and satisfy themselves about the weight, nature, hazardous/explosive properties, if any. In case they come across any material beyond the scope of the description of material, it should be informed JMRC immediately in writing by closing date & time for material inspection.
- ii. All the material offered for sale is on AS IS WHERE IS basis and where this is stacked. Material is sold on the assumption that bidders have inspected the same and know what they are buying, irrespective of whether they have first inspected the materials or not. No complaint shall be entertained in this regard.
- iii. The buyer has to lift the entire material and clear the site after making the required payment. In the event of actual quantity turning out to be less than the estimated quantity, the buyer shall not be entitled to claim any damages, loss of interest or compensation on this ground except the refund of material value for that short quantity from JMRC, Jaipur. The amount of Tax pertaining to such undelivered quantity shall not be refunded and required to be claimed by the buyer from the respective departments only.
- iv. The rates must be announced by bidder exclusive of all taxes, duties and any other levies etc. However the rate of GST prevailing at the time of making payment shall be applicable.
- v. The Bidders/customers workmen shall have to abide by the rules & regulation including safety & security regulation of the relevant statutory Acts. Entry inside the works/stores should only be against Gate pass for the men and equipment for which purchaser will have to apply well in advance before lifting commences.
- vi. The purchaser shall ensure that his workmen do not loiter around within the workshop/stores area of JMRC, Jaipur. They shall not touch any material except that material shown to them. If any of his workmen is even found violating this restriction, the purchaser shall be responsible for making good the loss to the owners on which their decision shall be final and binding.
- vii. Before participate in auction the Buyer, a presumption would be drawn that the buyer has inspected the material and has satisfied himself about the nature, quantity, quality, other technical specifications, taxes-duties. No complaint, whatsoever, on the points referred above, would be entertained after the submission of the bid.

- viii. The successful Bidders/customers need to deposit **Rs. 50,944/-** in the form of a banker's cheque or demand draft of a scheduled bank in favour of "**Jaipur Metro Rail Corporation Limited**" Payable at Jaipur, on the same date and time of auction as a part payment.
- ix. GST Rate as applicable on individual item mentioned in table-2 is applicable as per weightage shown in table-2.

### 6. Payment Terms:

- i. The accepted bid value of the scrap material along with all applicable taxes and duties are to be paid to JMRC by the highest bidder within 7 days from the date of letter of acceptance.
- ii. The highest bidder has to pay accepted bid value i.e. (Highest bid value in Rupees).
- iii. Final Payment shall be made by Demand Draft only. Cash payment shall not be accepted.
- iv. Earnest Money of the highest bidder shall be adjusted against the payment to be made by the bidder to JMRC.
- v. For any delay in making payment within the time limit specified, the due payment may be made together with late penalty 1% of the accepted bid value per week or part thereof on the due amount for the period of delay within 14 days from the due date. However, JMRC reserves the right not to accept the payment with or without the late penalty after the expiry of the above mentioned time limits or even within the aforesaid additional period of 14 days at JMRC sole discretion and in such an event the sale will be automatically cancelled; the Earnest Money Deposit & Advance payment of **Rs. 50,944/-** as per this document clause 5(viii) will automatically stand forfeited.
- vi. In case the date of submission of payment happens to fall on a Public Holiday, the next day shall be considered as the date of submission of payment

### 7. Lifting of Material:

- i. After making payment by successful bidder, Delivery Order will be issued by JMRC.
- ii. The Delivery of the scrap will be done as mentioned in the Table-2 of this document.
- iii. Material will have to be lifted by the Buyer by employing their own labour and transport at their own cost within 15 days from the date of Delivery Order including date of issue.
- iv. If the successful Bidder is unable to lift the material within stipulated period as specified in the delivery order, he can request the concerned Store in charge, in writing, to allow him to lift the material, as a special case, after paying penalty in advance up to 14 days @ 1% of the accepted bid value per week or part thereof on the balance un lifted material value. No further extension will be given to the bidder. If the successful Bidder unable to lift the material within the aforesaid 14 days then all the payments done earlier (EMD & Advance deposit payments) will be forfeited.
- v. The material will be delivered by JMRC on actual Quantity/Number(s) as stated in the auction description. Delivery will be made by JMRC in working day and hours only.
- vi. Buyer are required to lift the materials completely on clean sweep basis as to clear site failing which ground rent as applicable will be charged. Quantity

The scrap materials/items which come under the category of Hazardous Waste as per Hazardous Waste (Management & Handling) Act 1989 and Amendment Rule 2002 & 2003 shall be sold only to those buyers who are registered with Ministry of Environment & Forest, GoI / Central Pollution & Control Board.
- ix. Any Damage occurred to the property of JMRC during lifting/transport will lead to forfeiture of EMD/Penalty or both at the discretion of engineer in-charge on the basis of report of damage, if any.
