1. Required material should be strictly as per descriptions mentioned below.
 - (i) Combination Switch, Part No: MH71500031LN25174417SD00018.
 - (ii) Interlocking Lock, Product code: PMAI01, Drg. No: PMAI01-1L-FT-BC PRA-1/form: A, Engraving: H accessories PACS01 (flip cap) location roof access door, Make: Patlon.
 - (iii) Interlocking Key: Product code: Key 01, Drg. No: PI-Key 01, engraving: H,A,B,J,K,F,G Make: Patlon.

2. Offer from the firms who do not have a valid GST No. will not be entertained. GST No. Should be clearly indicated in offer and enclose Copy of GST Registration Certificate.
3. The rates quoted shall be for JMRC office, Mansarovar Metro Depot, Jaipur-302020, inclusive of all expenses i.e. all taxes (excluding GST), transportation charges, packing changes and loading/unloading charges etc; no other charges shall be paid by JMRC. GST will be paid at rate applicable at the time of billing.
4. Order will be given to one firm, based on overall lowest rates of item.
5. **Delivery Period:** The material is to be supplied within 2 months of issue of purchase order.
6. The above material shall be delivered at Custody Store Section, Room no. D20, Train maintenance Depot, Bhriagu Path, Mansarovar –Jaipur-302020 to JE/Custody Store, Cont. no. 07728895713.

8. **Warranty:** Warranty period shall be 06 months for manufacturing defects.
9. **Testing & Suitability condition:**
 - (i) Item No. 1 and 4 at para-1, are to be compatible for EFLT at Mansarovar Metro Depot of JMRC
 - (ii) Performance of all items will be monitored for duration of 10 days and thereafter technical suitability will be given.
10. **Penalty/Liquidated Damages:**
 - (i) If the contractor requires an extension of time on completion of contractual supply on account of occurrence of any hindrance he shall apply in writing for extension on occurrence of hindrance.
 - (ii) The Purchase Officer may extend the delivery period with or without liquidated damages in case they are satisfied that the delay in the supply of goods is on account of hindrances. Reasons shall be recorded.

- (iii) **Extension in delivery period:** In case of extension in the delivery period with liquidated damages the recovery shall be made on the basis of following percentages of value of stores which the tenderer has failed to supply :-
- (a) Delay upto one fourth period of the prescribed delivery period - **2.5%.**
- (b) Delay exceeding one fourth but not exceeding half of the prescribed delivery period - **5%.**
- (c) Delay exceeding half but not exceeding three fourth of the prescribed delivery period - **7.5%.**
- (d) Delay exceeding three fourth of the prescribed delivery period - **10%.**
- Note: Fraction of a day in reckoning period of delay in supplies shall be eliminated if it is less than half a day. The maximum amount of liquidated damages shall be **10%.**
11. The quantity of material may increase/decrease up to a certain limit (up to 25%) as per requirements.
 12. Bidder name, Bid no, due date & time should be mentioned on the sealed offer.
 13. Payment Terms-100% payment after receipt and acceptance of material.
 14. Inspection Authority: By JMRC representative.
 15. JMRC reserves the right to accept or reject any offer in whole or part without assigning any reason.
 16. Validity of offer: - Bidder is required to keep their offer open at least ninety days (90 days) from the date of bid opening.
 17. The offer shall be unconditional and duly signed; Conditional offer will be summarily rejected.
 18. If national holiday is being declared on tender due date tender will be opened on next suitable working day.
 19. All rights related to bidding process are reserved with JMRC.
 20. RTPPR-2013 will be applicable for procurement.
