JMRC will examine the factual details of Work awarded and satisfactory completion/performance of work by firm at time of Bid evaluation.</b></p> <p>I. <b>Definition of similar works:</b></p> <ol style="list-style-type: none"><li>1. The works completed here shall mean having physically completed that particular work.</li><li>2. The bidder firm should have <b>work experience of successful completion of any work pertaining to SITC/ Repairing/ Annual Maintenance Contract / Comprehensive Annual Maintenance work of Air Cooled chiller /water cooled chiller/ Central Air Conditioning/ AC Package</b> in any Central Govt. Department /State Govt. Department /PSUs of Central or any state Govt. / Any Metro Rail Projects in India/ Indian Railways or it's PSU's/ Autonomous body of Any Govt. <u>The completion certificate shall at least be comprised of following information: a. Name of work, b. Name of firm d. Name of agreement/LOA number. d. Date of Actual commencement work e. Date of actual completion of work f. Total value (Amount) of work done, g. The Bidder shall submit the details of the same as per Form-K.</p> <p>2. <b>Annual Turnover:-</b> The average annual turnover of applicant during last three audited financial years should not be less than forty percent (40%) of the estimated cost. To substantiate the Annual Turnover, Contractor needs to submit the Chartered Accountant (CA) Certificate.</p> |
| 17.  | <p><b>POWER OF ATTORNEY (Form H):</b> In case bidder's firm is Partnership/Company/Consortium then, a power of attorney to be submitted.</p> <p>The power of attorney is to be signed by the partners or legally authorized signatories of all the partners authorizing the nominated person to be In-charge to sign bid document, incur all liabilities and receive instructions.</p>  |
