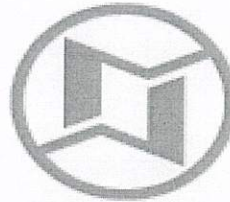

2. INSTRUCTIONS TO BIDDER

2.1 GENERAL

Online Bid is invited for the Bid No. **JMRC/O&S/RS/2026-27/NIB/003** towards Bid for "Train Window Glass Replacement Work" by Jaipur Metro Rail Corporation Limited hereinafter called the 'Employer', for Goods/Services/Works in accordance with this Bid Package. The Bid consist of the following documents, along with their Tables, appendices, addenda, corrigenda and errata if any.

- (ii) Instructions To Bidder (ITB)
- (iii) Special Terms and Conditions of Bid & Contract
- (iv) Scope of work

"The Rajasthan Transparency in Public Procurement Act, 2012 and the "The Rajasthan Transparency Public Procurement Rules, 2013" under the said Act have come into force which are available on the website of State Public Procurement Portal <https://sppp.rajasthan.gov.in>. The Bidders are advised to acquaint themselves with the provisions of the Act and the Rules before participating in the Bidding process. 2.2 BID DOCUMENTS

- 2.3.2 Bid security can be deposited in the form of Demand Draft/ Bankers Cheque/Bank Guarantee of amount defined in NIB key details in favour of Jaipur Metro Rail Corporation Ltd., payable at Jaipur, shall form part of the bid.
- 2.3.3 In lieu of bid security, a bid securing declaration shall be taken from Departments'/Boards of the State Government or Central Government; Government Companies as defined in clause(45) of section 2 of the Companies Act,2013; Company owned or controlled, directly or indirectly, by the Central Government, or by any State Government or Governments, or partly by the Central Government and partly by one or more State Governments which is subject to audit by the Auditor appointed by the Comptroller and Auditor-General of India under sub-section(5) or (7) of section 139 of the companies Act,2013; Autonomous bodies, Registered Societies, Cooperative Societies which are owned or controlled or managed by the State Government and Central Government.
- 2.3.4 Bid security shall be 2% of the estimated value of subject matter of procurement. In case of Small Scale Industries of Rajasthan it shall be 0.5% of the quantity offered for supply and in case of sick industries other than Small Scale Industries, whose cases are pending with Board of Industrial and Financial Reconstruction; it shall be 1% of the value of bid. (Please refer rule 42 of RTPPR i.e. Rajasthan Transparency in Public Procurement Rules, 2013. Proof of such exemption has to be submitted with the bid document. - 2.3.8 Notice will be given to the Bidder with reasonable time before Bid Security (EMD) deposited is forfeited.
- 2.3.9 No interest shall be payable on the Bid Security (EMD).
- 2.3.10 In case of the successful Bidder, the amount of Bid Security may be adjusted in arriving at the amount of the Performance Security, or refunded if the successful Bidder furnishes the full amount of performance security.
- 2.3.11 The procuring entity shall promptly return the Bid Security of the successful Bidder after the earliest of the following events, namely:-
- a) The expiry of validity of Bid Security;
 - b) The execution of agreement for procurement and performance security is furnished by the successful Bidder;
 - c) The cancellation of the procurement process; or

2. Save filled copy of downloaded financial bid file in your computer and remember its name & location for uploading correct file (duly filled in) when required.
3. Documents to be submitted by the bidder under bid package have been described under the respective Clause. This list of documents has been prepared mainly for the convenience of the bidder and any omission on the part of the Employer shall not absolve the bidder of his responsibility of going through the various clauses in the bid Documents including the specifications and to submit all the details specifically called for (or implied) in those clauses.

2.4.2 SUBMISSION OF PROPOSAL

2.4.2.1 PREPARATION FOR ONLINE SUBMISSION:

2. To participate in online bidding process, bidders must procure a Digital Signature Certificate as per Information Technology Act-2000 using which they can digitally sign their electronic bids. Bidders can procure the same from any CCA approved certifying agency, i.e. TCS, safe crypt, N code, etc. Bidders who already have a valid Digital Signature Certificate (DSC) need not procure a new DSC.

2. All pages of the bid document and the addendums/amendments uploaded by the JMRC on the website <http://eproc.rajasthan.gov.in> shall be deemed to have been initialed and accepted by the persons signing the bid when they submit their electronic bid.
3. The documents listed in ITB along with the addenda uploaded till the date of bid submission, shall be filled by the bidder to bind the bidder to the contract. All the pages of the bid and documents shall be digitally signed.
4. The uploaded documents for technical-bid or bid fee or processing fee or any other document required for e-bidding cannot be changed after closing date of bid and same documents are to be produced in original physical form in the office whenever asked to do so.
5. Utmost care to be taken to name the files /documents to be uploaded on portal. There should not be any special character or space in the name of file, only underscores are permissible. All Bids in which any of the prescribed conditions are not fulfilled or which have been vitiated by errors in calculations, totaling or other discrepancies or which contain over-writing in figures or words or corrections not digitally initialed and dated, may be liable to rejection.
6. Bids sent telegraphically or through other means of transmission (Email, Tele-fax etc.), which cannot be delivered in a sealed envelope, shall be treated as defective, invalid and shall stand rejected.

intimated to all such bidders separately by email. Bidders are also advised to keep abreast of the website for announcement of the date.

2.5.3 If national holiday is being declared on bid due date then bid will be opened on next suitable working day.

2.5.4 Preliminary Examination of Bids

a. The contents of the documents of the individual bids will be examined summarily in order to assess their formal conformity and agreement with the instructions and guidance to the Bidders and the completeness as per eligibility criteria and technical responsiveness. Any bid not conforming to any of these requirements may be disqualified forthwith at the discretion of Jaipur Metro Rail Corporation.

b. The ranking of L1, L2, L3 etc, will be done on basis of least Cost for overall items of financial BOQ. Bidder shall quote for all the items, failing which their bid will be summarily rejected.

c. In case, two or more responsive bidders quote the same overall price in BOQ, then JMRC will award the contract/PO/LOA to the bidder having the highest average annual turnover in the last three audited financial years i.e. year 2022-23, year 2023-24 and year 2024-25.

2.6 NEGOTIATION

2.6.1 Except in case of procurement by method of single source procurement or procurement by competitive negotiations, to the extent possible, no negotiations shall be conducted after the pre-bid stage. All clarifications needed to be sought shall be sought in the pre-bid stage itself.

2.6.2 Negotiations may, however, be undertaken only with the lowest or most advantageous bidder under the following circumstances-

- a) When ring prices have been quoted by the bidders for the subject matter of procurement; or
- b) When the rates quoted vary considerably and considered much higher than the prevailing market rates.

2.6.3 The bid evaluation committee shall have full powers to undertake negotiations. Detailed reasons and results of negotiations shall be recorded in the proceedings.

2.6.4 The lowest or most advantageous bidder shall be informed in writing either through messenger or by registered letter and email (if available). A minimum time of seven days shall be given for calling negotiations. In case of urgency the bid evaluation committee, after recording reasons, may reduce the time, provided the lowest or most advantageous bidder has received the intimation and consented to regarding holding of negotiations.

2.6.5 Negotiations shall not make the original offer made by the bidder inoperative. The bid evaluation committee shall have option to consider the original offer in case the bidder decides to increase rates originally quoted or imposes any new terms or conditions.

- 2.6.6 In case of non-satisfactory achievement of rates from lowest or most advantageous bidder, the bid evaluation committee may choose to make a written counter offer to the lowest or most advantageous bidder and if this is not accepted by him, the committee may decide to reject and re-invite bids or to make the same counter-offer first to the second lowest or most advantageous bidder, then to the third lowest or most advantageous bidder and soon in the order of their initial standing and work / supply order be awarded to the bidder who accepts the counter-offer. This procedure should be used in exceptional cases only.
- 2.6.7 In case the rates even after the negotiations are considered very high, fresh bids shall be invited.

2.7 AWARD OF CONTRACT & PERFORMANCE SECURITY DEPOSIT

- 2.7.1 Prior to delivery of items/material, Performance security shall be solicited from successful Bidder except the departments of the State Government and undertakings, corporations, autonomous bodies, registered societies, co-operative societies which are owned or controlled or managed by the State Government and undertakings of the Central Government. However, a performance security declaration shall be taken from them. The State Government may relax the provision of performance security in particular procurement or any class of procurement.
- 2.7.2 The amount of performance security shall be 5% of the amount of supply order/ Purchase order/LOA in case of procurement of goods and services. In case of small scale industries/MSME of Rajasthan it shall be one percent (1%) of the amount of quantity ordered for supply of goods and in case of sick industries, other than Small Scale Industries, whose cases are pending before the Board of Industrial and Financial Reconstruction (BIFR), it shall be two percent of the amount of supply order.

- (b) Every Micro, Small and medium enterprise shall be required to submit an affidavit in Form L, along with the duly filled bid document, to the Procuring entity.
- 2.7.3 Amount to be paid of performance security will be informed to successful bidder at the time of Purchase order/LOA.
- 2.7.4 Performance security shall be furnished in any one of the following forms: -

- c. Fixed Deposit Receipt (FDR) of a scheduled bank. It shall be in the name of procuring entity on account of Bidder and discharged by the Bidder in advance. The procuring entity shall ensure before accepting the FDR that the Bidder furnishes an undertaking from the bank to make payment/ premature payment of the FDR on demand to the procuring entity without requirement of consent of the Bidder concerned. In the event of forfeiture of the performance security, the Fixed Deposit shall be forfeited along with interest earned on such Fixed Deposit.

Subject to the provisions in the bidding document and contract, the execution of complete scope of work shall be executed as specified in the purchase order/LOA which will be issued by JMRC to the successful bidder.

2.10.3 Termination

The Bid sanctioning authority of JMRC may, without prejudice to any other remedy for breach of contract, by a written notice of default of at least 30 days sent to the supplier/ Contractor, terminate the contract in whole or in part: -

2.10.4 Transportation:

4 SCOPE OF WORK:

4.1 Scope of Work

- (i) The contractor shall provide all manpower, materials, consumables (Adhesive/Sealant, primer, activator, cleaner, sandpaper, scotch bright, cotton cloth, brush, masking tape, rope, rubber packing, spacer, rubber spreader etc), tools, etc. except glass, for fixing/replacement of the glasses. New train glasses will be provided by JMRC to the contractor at JMRC depot.
- (ii) Ladder/Trolley to be used during glass replacement work will be provided by JMRC if required by contractor.
- (iii) The contractor shall have to deploy sufficient well-trained staff for replacement of train glasses. The personnel deployed should be qualified, trained, efficient and competent in the relevant work and have the knowledge of glass replacement and safety procedures.
- (iv) Quantity given in BOQ may vary as per requirement of JMRC during the contract period.

4.2 SITE OF WORK:

The work shall be executed at Mansarovar Depot/premises of Jaipur Metro Rail Corporation Ltd (JMRC).

4.3 RESPONSE TIME:

- i. Contractor shall provide an active mobile no. and E-mail ID of their representative.
- ii. Requisition from JMRC side for glass replacement to above mobile no. and Email Id shall be made between 9 a.m. to 6 p.m. (Including Saturday, Sunday and Holiday).
- iii. **Response time (Max.):** Within seven days after the day of requisition by JMRC representative via mail/telephonically.
- iv. Mostly the work shall be executed as per requirement of JMRC. The work can be executed in day as well as in night hours based on train availability.
- v. Maximum replacement time of one glass will be 8 hours.

4.4 WORK PREMISES AND OPERATION CONDITIONS:

- i. The work is to be carried out under the supervision of JMRC representative only.
- ii. Electricity, water & pneumatic air will be provided by JMRC free of cost solely for the purpose of the glass replacement. However, contractor shall ensure efficient and minimum use of above resource. Necessary arrangements for extending above facilities up to the point of use shall be carried out by contractor at its own cost.
- iii. Disposal of waste generated during replacement of glasses upto the nearest disposal point in depot shall be arranged by the Contractor.

4.5 WORK MATERIAL:

- i. Contractor shall carry small packing sizes of Primer, Activator and Sealant for one time

use as per size of glass.

- ii. Depot representative shall check the make, model & intactness of seal and validity of expiry of the sealant tube/packet. Open packet of sealant shall not be used.
- iii. Set of Sikaflex 265/Sikaflex 268 power cure sealant, Sika Activator 205, Sikaflex Primer 206 G+P or set of Terostat 8590 sealant, Terostat 8511 activator & Terostat 8550 cleaner shall be used for replacement of glasses except for windscreen of RS-8 trains.
- iv. For replacement of RS8 windscreen/front glass lower and upper, only Sikaflex265/Sikaflex268 power cure sealant shall be used.

4.6 INSPECTION OF GLASSES AFTER REFIXING:

Inspection of fixed glasses after fixing on Train shall be done by the depot representative and Joint note for this will be signed.

4.7 PHOTO IDENTITY CARDS:

All staff/representative of contractor shall wear neat & smart dress (Shirt, Pant, shoes etc.). All contractors' staff shall be provided with Photo Identity cards. A copy of the photo Identity card will be submitted to the Employer.

4.8 ENTRY/EXIT PASS:

JMRC shall provide entry exit pass to the staff deputed after submittal of contractor's photo identity card and indemnity bond (In JMRC's standard format) by the contractor.

4.9 Contract Period

- a. Subject to the conditions of the contract, contract period will be 2 years from date of issue of LOA and extendable as per RTPPR- 2013.
- b. The above work shall be completed at JMRC, Workshop building, Train maintenance Depot, Mansarovar -Jaipur-302020.
- c. The Contractor shall arrange work within the stipulated time period.

4.10 Rejection

- a. Materials not approved during inspection or testing shall be rejected and will have to be replaced by the Contractor at his own cost within the time fixed by the Purchase Officer.
- b. If, however, due to exigencies of work, such replacement either in whole or in part, is not considered feasible, the Purchase Officer after giving an opportunity to the Contractor of being heard shall for reasons to be recorded, deduct amount from the quoted rates as per BOQ. The deduction so made shall be final.
- c. The rejected articles shall be removed by the supplier/ Bidder/ Contractor within 15 days of intimation of rejection, after which Purchase Officer shall not be responsible for any

loss, shortage or damage and shall have the right to dispose of such articles as he thinks fit, at the Contractor's risk and on his account.

4.11 Penalty/Liquidity Damage

- (i) If the Contractor fails to provide satisfactory services as per terms and conditions of the contract, the Employer shall have the right to impose penalty and recover/adjust the penalty from the dues payable to the Contractor.
- (ii) In addition to above if any glass is broken by the contractor or its staff during glass replacement work, the cost of broken glasses plus 20% shall be paid by contractor or deducted from bill.
- (iii) If any replaced glass falls off the train within 6 months after replacement then the cost of broken glass plus 20% and replacement cost shall be deducted from bill.
- (iv) Sum of all penalties mentioned in point no. (i) to (iii) for one quarter shall not exceed 10 % of the quarterly billed amount. If sum of all penalties for three consecutive quarters is 10% or higher of respective bills then termination process as per GCC shall be initiated.
- (v) If any damage to the train / equipments is done by the contractor or its staff, the cost of attending such damage shall be borne by the contractor.
- (vi) **Extension in delivery/service period:** In case of extension in the Service/replacement period for window glass with liquidated damages the recovery shall be made on the basis of following percentages of value of window glass which the tenderer has failed to supply :-
 - a. Delay upto one fourth period of the prescribed delivery period - **2.5%.**
 - b. Delay exceeding one fourth but not exceeding half of the prescribed delivery period - **5%.**
 - c. Delay exceeding half but not exceeding three fourth of the prescribed delivery period - **7.5%.**
 - d. Delay exceeding three fourth of the prescribed delivery period - **10%.**

Note: Fraction of a day in reckoning period of delay in supplies shall be eliminated if it is less than half a day. The maximum amount of liquidated damages shall be **10%.**

4.12 Payment Terms and Schedule

- a.) The currency or currencies in which payments shall be made to the supplier/ Contractor under this Contract shall be Indian Rupees (INR) only.
- b.) Bills, correct in all respect, shall be submitted in the favour of JMRC, Jaipur with bank details in duplicate along with the acceptance certificate and relevant documents, if any, for arranging payment.
- c.) Advance Payment will not be made by JMRC.
- d.) All remittance charges will be borne by the supplier/ Contractor.
- e.) For the purpose of On-account payment, the contractor shall submit detailed activities carried out as per BOQ in jointly signed work completion report by JMRC representative and Contractor representative and tax invoice for the item actually executed for checking and payment.
- f.) Payment will be effected based on unit rates as approved in the Bill of Quantities.

- g.) The payment shall be made on **quarterly basis** for the work carried out as per LOA.

4.13 SAFETY INSTRUCTION:

- i. Contractor shall adopt all necessary safety procedures to avoid any type of accidents to men and material. JMRC 's' Safety Do's and Don'ts' will be provided after award of the contract.
- ii. Contractor's staff shall use adequate PPEs for safety during replacement of glasses.
- iii. While replacing the glass, no other part of the train shall be disturbed/touched.
- iv. Contractor or its staff on noticing anything unusual (Like flashing, sparking, fire, theft, damage, abnormal sound etc.) shall immediately bring in notice of PPIO.

Note: JMRC shall have the right to make minor alterations/additions/substitution in the Scope of work or issue instructions that may be deemed necessary during the period of the contract and contractor shall carry out the work in accordance with the instructions which may be given to him by authorized JMRC representative.

4.14 Other Special Terms

- ii. In case the Bidder fails to complete the work within stated timelines, the Penalty as per clause "Penalty" would be applicable.
- iii. In case of any errors/ inaccuracies remain in window glass fixing/installation services even after the final approval of design from the purchaser then the Contractor has to take corrective actions on Bidders part (including all related expenditure on any such measures). In such cases, due to delay in work completion schedule, the Penalty as per clause "Penalty " would be applicable.

Provided further that in case a Procuring Entity evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter of Financial Bids may be filed only by a Bidder whose Technical Bid is found to be acceptable.

(2) The officer to whom an appeal is filed under Para (1) shall deal with the appeal as expeditiously as possible and shall endeavor to dispose it within thirty days from the date of the appeal.

(3) If the officer designated under para (1) fails to dispose of the appeal filed within the period specified in para (2), or if the Bidder or prospective bidder or the Procuring Entity is aggrieved by the order passed by the First Appellate Authority, the Bidder or prospective bidder or the Procuring Entity, as the case may be, may file a second appeal to Second Appellate Authority specified in the Bidding Document in this behalf within fifteen days from the expiry of the period specified in para (2) or of the date of receipt of the order passed by the First Appellate Authority, as the case may be.

(4) Appeal not to be in certain cases

No appeal shall lie against any decision of the Procuring Entity relating to the following matters, namely:-

- (a) determination of need of procurement;
- (b) provisions limiting participation of Bidders in the Bid process;
- (c) the decision of whether or not to enter into negotiations;
- (d) cancellation of a procurement process;

- (e) Applicability of the provisions of confidentiality.

(5)Form of Appeal

- (a) An appeal under para (I) or (3) above shall be in the annexed Form along with as many copies as there are respondents in the appeal.
- (b) Every appeal shall be accompanied by an order appealed against, if any, affidavit verifying the facts stated in the appeal and proof of payment of fee.
- (c) Every appeal may be presented to First Appellate Authority or Second Appellate Authority, as the case may be, in person or through registered post or authorized representative.

(6)Fee for filing appeal

- (a) Fee for first appeal shall be rupees two thousand five hundred and for second appeal shall be rupees ten thousand, which shall be non-refundable.
- (b) The fee shall be paid in the form of bank demand draft or banker's cheque of a Scheduled Bank in India payable in the name of Appellate Authority concerned.

(7)Procedure for disposal of appeal

- (a) The First Appellate Authority or Second Appellate Authority, as the case may be, upon filing of appeal, shall issue notice accompanied by copy of appeal, affidavit and documents, if any, to the respondents and fix date of hearing.
- (b) On the date fixed for hearing, the First Appellate Authority or Second Appellate Authority, as the case may be, shall,-
- (i) Hear all the parties to appeal present before him; and
- (ii) Peruse or inspect documents, relevant records or copies thereof relating to the matter.
- (c) After hearing the parties, perusal or inspection of documents and relevant records or copies thereof relating to the matter, the Appellate Authority concerned shall pass an order in writing and provide the copy of order to the parties to appeal free of cost.
- (d) The order passed under sub-clause (c) above shall also be placed on the State Public Procurement Portal
