



1. NOTICE INVITING BIDS

- 1.1 Jaipur Metro Rail Corporation (JMRC) Ltd. invites Bids (**Single stage two envelope method**) "Comprehensive Annual Maintenance Contract of X-BIS Machine (Model No: RAP-620XR) for Five Years installed at Nine Metro Stations of JMRC Phase-1A" through e-tendering process i.e. by online tendering process.
- 1.2 The complete Bid document can be downloaded for online submission from the state e-procurement website <https://eproc.rajasthan.gov.in> and the interested Bidders will have to submit their offer in electronic formats both for technical and financial Bid on this website with their digital signatures. Unsigned Bids will not be entertained and will be rejected outright.

Bidder is required to submit the details as per Form-K along with supporting documents: The Bidder shall attach copy of LOAs / POs/Work Orders along with their individual work completion certificates issued by the authorized signatory preferably on their letter head of the contract/work awarding agency, mentioning Period of the contract, work completion date, name of the work and Amount paid for the contract, BOQ. <u>For bidders submitting LOA/P.O. of JMRC for work Experience need not to submit Work completion certificates. JMRC will examine the factual details of Work awarded and satisfactory completion of work/Performance by firm at time of Bid evaluation.</u></p> <p>II.
