Subject :- Delegation of powers by Regional Transport Authority to its Secretaries of respective regions posted as R.T.Os.

Whereas it is considered necessary in public interest to delegate certain powers of Regional Transport Authority to its Secretaries posted as R.T.Os under sub-section (5) of section 68 of the Motor Vehicles Act, 1988 read with rule 5.4 of Rajasthan Motor Vehicles Rules 1990.

It is, therefore, resolved in supersession of all previous resolutions in this regard, to delegate the following powers of the Regional Transport Authority to its Secretaries posted as R.T.O's for Jaipur (North), Jaipur (South), Jodhpur, Udaipur, Bikaner, Ajmer, Alwar, Kota, Sikar, Pali, Chittorgarh, Dausa & Bharatpur Regions :-

(I) To decide matters pertaining to :

- (i) Stage carriage permits on routes under sections 71, 72 and 81 of the Act, except Inter-State routes.
- (ii) Stage carriage permits under section 71, 72 and 81 of the Act for three wheeled passenger vehicles having seating capacity more than six passengers excluding the driver.
- (iii) Grant/Refuse the renewal of stage carriage permits, the additional services in the existing routes or permits and reduction in services on stage carriage permits for regional routes (including amalgamated regional routes)
- (iv) To countersign stage carriage permits of other states issued within scope and are in pursuance of interstate agreement under section 88 of the Act.
- (v) Temporary permits of contract carriage for non-nationalised areas or to stage carriages on non-nationalised route with overlapping facility in case of stage carriages on nationalized route if already allowed by Regional Transport Authority on existing route under clause (a) or (b) or (d) of sub-section (1) of section 87 of the Act.
- (vi) National permits of Goods carriages under sub-section (12) of Section 88 of the Act. (In case of Jaipur (South) this power will be exercised by Adl. R.T.O. Jagatpura (Jaipur))
- (vii) Transfer of permit under section 82 of the Act for which he is the granting Authority under delegation except interstate stage carriage permits.
- (viii) Permits temporary replacement under rule 5.35 of Rajasthan Motor Vehicles Rules 1990 read with section 83 of the Motor vehicles Act, 1988 by a spare vehicle (or a link route vehicle) of a model not below the prescribed for renewal for each class of route for a period not exceeding 30 days at a time only for repairs of a vehicle and without permission for sales of vehicle, covered by the permit. The total period of temporary replacement even in case of body building and major repairs should not exceed 90 days in one calendar year. The permit holder will also intimate the repair/body building site.
- (ix) Replacement under section 83 of one vehicle covered by a permit (Other than temporary permit) for which he is the granting authority under delegation by another vehicle (non covered by any



permit) of prescribed model and of same nature subject to the vehicle being readily available with him and also is in his name. For the purposes of replacement of vehicle the prescribed model shall mean the model prescribed for grant of permit.

- (2) To cancel or refuse to cancel a permit on an application made by the permit holder under rule 5.35 of Rajasthan Motor Vehicle Rules, 1990 (Except on Inter-State routes covered under reciprocal agreements.)
- (3) To approve the time table and fare chart of stage carriage under section 72 of the Act.
- (4) To issue notice and to decide the matter under section 86 of the holder of a permit for which he is a permit granting authority under delegation.
- (5) To do all ministerial acts on behalf of the Regional Transport Authority.

Note :- While exercising above delegated powers :-

- (i) Secretary shall ensure that at least at the time of issue of permit or making any endorsement on a permit issued by him the vehicle is registered in the name of the applicant unless relaxation is granted by the Regional Transport Authority.
 - (ii) Secretary shall ensure the compliance of all directions given by the State Transport Authority to Regional Transport Authority from time to time and of all provisions of Motor Vehicles Act, 1988 and Rules made there under.
 - (iii) Secretary shall ensure the compliance of the provisions of section 69 of the Motor Vehicles Act, 1988
 - (iv) Secretary while granting time table for plying of stage carriage the following running hours (including halting time) should be observed in the interest of the traveling public.

Whereas it is considered necessary in public interest to delegate some of the powers of Regional Transport Authority to its Additional Secretaries posted as Additional R.T.Os in Regional Transport offices (Excluding Jaipur (North), Jaipur (South) and Jodhpur) under sub-section (5) of section 68 of the Motor Vehicles Act 1988 read with rule 5.4 of Rajasthan Motor Vehicle Rules 1990.

It is, therefore, resolved in supersession of all previous resolution in this regard, to delegate the following powers of the Regional Transport Authority to the Additional Secretaries posted as Additional R.T.O's in Regional Transport Offices for the respective headquarter district of Udaipur, Bikaner, Ajmer, Alwar, Kota, Sikar, Pali, Chittorgarh, Dausa and Bharatpur Regions :-

(1) To decide matters pertaining to :

- (i) Contract carriage permits for motor cabs, maxi cabs & omni buses having seating capacity above 13 in all under section 74 and 81 of the Act excluding Inter-State permits under reciprocal agreement.
- (ii) Contract carriage permit for three wheeled vehicles under section 74 and 81 of the Act.
- (iii) Goods carrier permits for All Rajasthan (excluding National Permit under sub-section (12) of section 88 and Inter State Permit under reciprocal agreements) Under sections 79 and 81 of the Act.
- (iv) Private Service vehicle permit under section 76 and 81 of the Act provided that vehicle is registered in the name of applicant firm/company or vehicle is taken on lease by the company and lease agreement entered in registration certificate of vehicle.
- (v) A permit in respect of educational institution vehicle.
- (vi) Special temporary permit for one return trip only under section 88 (8) of the Act.
- (vii) Goods carriage temporary permit under sub-section (7) of Section 88 of the Act.
- (viii) Transfer of permit under section 82 of the Act for which he is the granting Authority under delegation.
- (ix) Replacement of one vehicle covered by a permit (Other than temporary permit) for which he is the granting authority under delegation by another vehicle (not covered by any permit) of prescribed model of same nature under section 83 of the Act and subject to the condition that the vehicles is readily available with him and also in his name. For the purpose of replacement of vehicle the prescribed model shall mean the model prescribed for grant of permit.

(2) To issue notice and to decide the matter under section 86 of the holder of a permit for which he is a permit granting authority under delegation.



- (3) To cancel or refuse to cancel a permit for which he is a permit granting authority on an application made by the permit holder under rule 5.35 of Rajasthan Motor Vehicle Rules 1990.
- (4) To do all ministerial acts on behalf of the Regional Transport Authority.

- (iv) Contract Carriage Permit under section 74 for the vehicles other than Motor cabs and maxi cabs shall be granted only for non-nationalized area or route.
