The permit of other State will be countersigned by the Secretary, Regional Transport Authority, in whose jurisdiction the route of the stage carriage enters the State of Haryana.

2. All the Secretaries, Regional Transport Authority shall ensure that Registration No. of the bus is written on the permit. It should be ensured that more than one bus is not plied on a permit.

3. Secretary, RTAs shall personally ensure that the permits are countersigned strictly according to the reciprocal agreements. No permit shall be countersigned over and above the agreed quota under the reciprocal transport agreements.

4. Proper record of the permits countersigned shall be maintained by the Secretaries, Regional Transport Authority.

5. It shall also be ensured that no bus of other State is plied without countersignatures.
