NOTIFICATION

In exercise of the powers conferred by section 4B of the Rajasthan Motor Vehicles Taxation Act, 1951 (Rajasthan Act No. 11 of 1951), the State Government hereby makes the following amendment in this department's notification no. F6(179)/Pari/Tax/Hqrs/95 / 11K, dated 31.3.2006, with effect from 1.8.2007, namely:-

AMENDMENT

In the said notification, the existing proviso (5), appearing below the Table, shall be substituted by the following provisos; namely:-

- "(5) the motor vehicles falling under the sub-clauses (v), (vi) and entry (b) of sub-clause (vii) of clause 2 and plying exclusively within the municipal limits or U.I.T. limits or both, the Special Road Tax shall be payable at the rate of 50% of the rate as mentioned against each in column no. 2 subject to a maximum of Rs.12500/- per month.
- (5a) the motor vehicles falling under the entry (a) of sub-clause (vii) of clause (2) and sub-clause (viii) of clause 2 and plying exclusively within the municipal limits or U.I.T. limits or both, the Special Road Tax shall be payable at the rate of 9% of the cost of the chassis/vehicle per annum, subject to a maximum of Rs. 12,500/- per month."
