Sub: Regarding registration of trailers manufactured by M/s. Saraswati Trailer Udhog LLP, B-6-13 Automobile Nagar, Jaipur, Rajasthan.

All registering authorities are instructed that semi-trailers manufactured by M/s. Saraswati Trailer Udhog LLP, B-6-13 Automobile Nagar, Jaipur, Rajasthan may be registered in the State subject to compliance of provisions of the Motor Vehicles Act, 1988 and rules made there under and the department's instructions/orders issued from time to time in this regard.

The sanction of registration of the semi-trailers have been allowed by the Transport Department on the basis of the Type Approval Certificate no. ICAT/CMVR/GSR 409(E)/SARASWATI/0211/M-0475 dated 31-03-2017 issued by International Centre For Automotive Technology (hereinafter referred as ICAT, Manesar). - (5) the semi-trailer is attached with a suitable tractor or truck.
- (6) the Gross vehicle weight is assigned to the vehicle as per S.O. 728(E) dated 18.10.1996.
