Sub: Regarding registration of trailers manufactured by M/s. Truck Zone Corp., Narain Vihar, E- Block, Asarpura Gopalpura Bye pass Road, Ajmer Road, Jaipur, Rajasthan.

All registering authorities are instructed that semi-trailers manufactured by M/s. Truck Zone Corp., Narain Vihar, E- Block, Asarpura Gopalpura Bye pass Road, Ajmer Road, Jaipur, Rajasthan may be registered in the State subject to compliance of provisions of the Motor Vehicles Act, 1988 and rules made there under and the department's instructions/orders issued from time to time in this regard.

The sanction of registration of the semi-trailers have been allowed by the Transport Department on the basis of the Type Approval Certificate no. ICAT/CMVR/GSR 409(E)/TZC/1175/M-0698 dated 16-05-2017 issued by International Centre For Automotive Technology (hereinafter referred as ICAT, Manesar). The details of the semi-trailers so approved are given hereunder:


The above approval is subject to the condition that manufacturer shall be responsible to ensure the fitment of the approved component, parts etc. in the semi-trailer. The copy of type-approval certificate along with detailed specification issued by ICAT, Manesar is enclosed.

The manufacturer shall submit a certificate in form-22A Part-1 prescribed in CMVR, 1989 at the time of registration of the vehicle.

In addition to the above the registering authority shall also before registering the vehicle, ensure that;

- (1) The articulated vehicle, semi-trailer complies with the relevant provision of the Motor Vehicles Act, 1988 and the rules made there under.
- (2) The semi-trailer is attached with a suitable tractor or truck.
- (3) The Gross vehicle weight is assigned to the vehicle as per S.O. 728(E) dated 18.10.1996.
- (4) This certificate is valid after obtaining a valid Trade-Certificate from a concerned District Transport Office.
