All registering authorities are instructed that semi-trailers manufactured by M/s. Tranztar Commercial Vehicle Applications Limited, Plant 1:Survey No 194/1, Bhuj Bhachau Road, 34 K M Milestone, Kanaiyabe, Bhuj, Kachchh, Gujrat-370020 may be registered in the State subject to compliance of provisions of the Motor Vehicles Act, 1988 and rules made there under and the department's instructions/orders issued from time to time in this regard.

The sanction of registration of the semi-trailers have been allowed by the Transport Department on the basis of the Type Approval Certificate no. ICAT/CMVR/GSR409(E)/TRZ3FB/0205/N-1138 dated 13-06-2018 issued by International Centre For Automotive Technology (hereinafter referred as ICAT, Manesar). The manufacturer shall submit a certificate in form-22A Part-1 prescribed in CMVR, 1989 at the time of registration of the vehicle.

In addition to the above the registering authority shall also before registering the vehicle, ensure that;

- (1) The articulated vehicle, semi-trailer complies with the relevant provision of the Motor Vehicles Act, 1988 and the rules made there under.
- (2) The semi-trailer is attached with a suitable tractor or truck.
- (3) The Gross vehicle weight is assigned to the vehicle as per S.O. 728(E) dated 18.10.1996.
- (4) This certificate is valid after obtaining a valid Trade-Certificate from a concerned District Transport Office.
