NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 3 of the Rajasthan Motor Vehicles Taxation Act, 1951 (Act No.11 of 1951) and in supersession of this department's Notification number F.6(298)/Pari/Tax/Hqrs/ 2015/29238-50, dated 29.11.2019, the State Government being of the opinion that it is expedient in public interest so to do, hereby exempts Motor Vehicle Tax payable exceeding Rupees 15000/- per month under section 4 of the said Act, on the air conditioned passenger vehicles, except sleeper coach having seating capacity more than 12 including driver, subject to the following conditions, namely:-

- (i) that the Vehicle shall be registered in the State of Rajasthan in the name of tourist transport operator;
- (ii) that the tourist permit of the vehicle shall be issued by competent authority of State of Rajasthan in the name of recognized tourist operator; and
- (iii) that the tourist transport operator shall be recognized by Ministry of Tourism, Government of India or Tourism Department, Government of Rajasthan, Indian Association of Tour Operators (IATO) and Rajasthan Association of Tour Operators (RATO) and approved as such by the Transport Commissioner.

This notification shall have effect from 29.11.2019 and shall remain in force upto 30.06.2020.
