

विषय- कार्यालय आदेश 13/2022 की निरन्तरता में अपेक्षित बैंक गारंटी के संबंध में।

सड़क परिवहन एवं राजमार्ग मंत्रालय, भारत सरकार द्वारा दिनांक 23.09.2021 को अधिसूचना क्रमांक जी.एस. आर 653(ई) जारी कर पर्यावरण सुरक्षा के लिए प्रदूषणकारी वाहनों को नष्ट करने एवं सड़क पर चलने में असक्षम वाहनों को कम करने के उद्देश्य से भारत सरकार द्वारा वाहन स्क्रैपिंग नीति शुरू की गई। इसमें मोटर यान (यान स्क्रैपिंग सुविधा का रजिस्ट्रीकरण और कार्य) नियम, 2021 अन्तःस्थापित किये गये। इन नियमों को राजस्थान राज्य में लागू करने के लिए विभाग द्वारा कार्यालय आदेश 13/2022 दिनांक 30.06.2022 जारी किया गया। मोटर यान (यान स्क्रैपिंग सुविधा का रजिस्ट्रीकरण और कार्य) नियम, 2021 के नियम 6 के प्रावधानानुसार रजिस्ट्रीकृत यान स्क्रैपिंग सुविधा के आवेदकों से परिशिष्ट -1 में उल्लेखित प्रारूप के अनुसार बैंक गारंटी लिया जाना अनिवार्य होगा।

(hereinafter called " ") as a part of an application for Registered Vehicle Scrapping Facility (RVSF) of End of Life Vehicles to the Transport Commissioner, Government of Rajasthan having its office at Parivahan Bhawan, Sahkar Marg, Jaipur (hereinafter referred to as the "Registration Authority") have agreed to deposit as Earnest Money deposit with the Registration Authority by way of Bank Guarantee of 10,00,000/- (Rupees Ten Lakhs only) (hereinafter referred to as "Bank Guarantee") which will be issued to the Registration Authority along with the application of Registered Vehicle Scrapping Facility for scrapping of End of Life Vehicles and complete dismantling disposal of non-reusable parts of Motor Vehicles and issuance of Certificate of Vehicle Scrapping to the registered owner of Motor Vehicles (hereinafter referred "Application") by(RVSF) to the Registration Authority.

We.....having registered office atand acting through its branch office at (hereinafter called as "the Bank expression shall, unless repugnant to the context or meaning thereof, include its successor and assigns) being the Guarantor under this Bank Guarantee, hereby irrevocably and unconditionally undertake to forthwith and immediately pay to the Registration Authority a sum of Rs. 10,00,000/- (Rupees Ten Lakhs only) without any demur, merely on demand of Registration Authority and submitting a written claim or demand along with a copy of the order passed by the Registration Authority against... (RVSF) for any violation of issued under Rules Motor Vehicle (Registration and Function of Vehicle Scrapping Rules, 2021, dated 23.09.2021.

We the Bank further agree that the guarantee herein contained shall remain in full force from the date of application for a period of ten years (the initial registration period) plus 60 days plus 90 days till released by the Registration Authority.

We the Bank lastly undertake not to revoke this guarantee during its currency except with previous consent of the Registration Authority in writing.

Any claim or dispute arising under the terms of this document shall only be enforced or settled in Courts at Jaipur.

The guarantor hereby declares that it has the power to execute this Bank Guarantee and the executant has full powers to do so on its behalf under the authority granted to him by the guarantor.

Further, the Bank certifies that this Bank Guarantee is adequately stamped under the relevant State Stamp Act and any deficiency in execution of this Guarantee shall not have the effect of relieving them.
